90-Year Old Former POW Guest Speaker Highlights Military & Veterans Day at the Legislature



Former Korean War U.S. Army Private 1st Class and ex-Prisoner of War (POW) Manuel Martinez (*left and below photos*) was the featured speaker on *Military & Veterans Day at the Legislature* at the State Capitol in Santa Fe on January 25.

His appearance capped the annual day during the legislature presented by the New Mexico Department of Veterans Services (DVS) and the New Mexico Department of Military Affairs to honor the service and sacrifice of New Mexico's active-duty military personnel and military veterans.

Every year, a particular segment of the military is featured at a noon ceremony in the Rotunda. The focus at this year's ceremony was on POW's and those still listed as Missing in Action (MIA). PFC Martinez, from the small

and those still listed as Missing in Action (MIA). PFC Martinez, from the small northern New Mexico town of Truchas, was a Machine Gunner in the Army's 3rd Division. He was taken prisoner by North Korean forces on September 27, 1952, when his unit came under heavy fire.

"By the grace of God, I escaped serious injury—except for a few shrapnel wounds," said Mr. Martinez in his remarks at the ceremony. "My assistant gunner was seriously wounded. While I was tending to his wounds, I was taken captive."

Mr. Martinez, a longtime resident of Pojoaque, was among seven soldiers of his unit taken prisoner on that day. He mentioned the poor conditions—being fed meager rations of boiled vegetation...and Maize—which, because of his rural upbringing in northern New Mexico, he recognized as cattle feed.



"I was told by other prisoners in the camp that those captured before us suffered much more inhumane conditions," he recounted. "Some were brutally murdered without cause. Many starved to death. Many died from lack of medical care; others, from exposure to the extreme cold. But conditions gradually improved. We were given rice for the first time... and were being fed twice a day."

Mr. Martinez spent eleven months in captivity—being liberated a month after North and South Korea signed an Armistice on July 27, 1953, to cease hostilities between the two countries. He spent nearly three months recovering and rehabbing at Fizsimons Army Medical Center in Denver before returning home to northern New Mexico, where he opened a hardware store in Pojoaque.

"This has been an honor for me," he said at the conclusion of his remarks. "It is not easy for many of us to re-live the memories. I lost two friends who took their own lives after the war—one of them I met in the prison camp; the other one, after the war. But I moved on, and am very thankful for what I have today."

80-year old Aubrey Nichols was a Navy Lt. Cmdr. who was shot down while flying his A-7 Corsair on a combat mission over North Korea on May 19, 1972. He was released from the Hoa Lo Prison (the "Hanoi Hilton") eleven months later. After recuperating, he returned to active duty...retiring from the Defense Nuclear Agency Field Command at Kirtland AFB in 1988.

94-year old Ralph Nelson was a WWII Army infantryman who was among several in his unit who were captured during the Battle of the Bulge in December of 1944. He

was released shortly after Germany formally surrendered to Allied forces on May 8, 1945. After his recuperation & rehabilitation, Mr. Nelson eventually became a long-time dentist in Los Alamos.

"Though America is thankful there are no U.S. troops currently in captivity, there are still nearly 82,000 Americans who remain missing from previous wars," she said in her remarks preceding the address by Mr. Martinez. "It pains me to think there are tens of thousands of families still grieving for long-lost family members from as far back as World War I. America must continue to locate and identify the remains of our long-lost missing, and bring them home to their final resting place."

As you entered the rotunda today, you may have noticed a small table in a place of honor. It is set for one. This table is our way of symbolizing the fact that members of our profession of arms are missing from our midst. They are commonly called POWs or MIAs. We call them comrades. They are unable to be with their loved ones and families today, so we join together to pay our humble tribute to them, and bear witness to their continued absence.



This table set for one is small--symbolizing the frailty of one prisoner alone against his or her suppressors. The tablecloth is white--symbolizing the purity of their intentions to respond to their country's call to arms. The single red rose displayed in a vase reminds us of the families and loved ones of our comrades-in-arms who keep the faith awaiting their return.

The yellow ribbon tied so prominently on the vase is reminiscent of the yellow ribbon worn upon the lapel and breasts of thousands who bear witness to their unyielding determination to demand a proper accounting of our missing. A slice of lemon is on the bread plate to remind us of their bitter fate There is salt upon the bread plate--symbolic of the families' tears as they wait. The glass is inverted. They cannot toast with us this afternoon. The chair. The chair is empty. They are not here. The candle...is reminiscent of the light of hope which lives in our hearts to illuminate their way home, away from their captors, to the open arms of a grateful nation.

Let us remember and never forget their sacrifices.

DVS Promotes Veterans Service Officer to State Benefits Bureau Chief

DVS has promoted Santa Fe-based Veterans Service Officer (VSO) Jeff George to fill its vacant State Benefits Bureau Chief position.

Mr. George, a former Army M1A1 Tank crew member, has been with DVS since March of 2008. In his new position, he will manage the agency's bureau that oversees the many state veterans' benefits available to New Mexico's veterans...such as the \$4,000 veterans state property tax exemption off the total valuation of a primary residence, and disabled veteran Game & Fish licenses—the two most filed-for state veteran's benefits with DVS.

He will report directly to State Benefits Division Director Ed Mendez.

In his previous VSO position with the agency Mr. George assisted veterans and widows of veterans with filing for their federal VA and state veterans' benefits (below photos), . This often-complicated process, if done incorrectly by self-filing veterans, could result in long wait-times to receive the benefit, receiving a less-than-optimal amount of the benefit, or a denial based on incorrect or

The decision to promote from within to fill the vacant bureau chief position was an easy one, said DVS Secretary Judy Griego.

"There were several outstanding candidates for the vacancy, but it was clearly evident that Jeff was the right person for the job," said Secretary Griego. "He has an outstanding knowledge of veterans benefits, and a strong commitment to helping veterans file for their benefits. I'm confident Jeff will help make the DVS Benefits Bureau even stronger."

One of his main functions will be to help identify future state veterans' benefits, and work with Director Mendez and Secretary Griego to develop legislation for passage into state law. He will also work with the Field Services Division to coordinate state veterans' benefits outreach efforts, and look for additional ways to improve overall efforts to better serve New Mexico's 154,172 veterans.

A search is underway to fill the DVS Santa Fe VSO vacancy.

DVS, Bernalillo County Hosts First Veterans State Property Tax Exemption Outreach of 2020



DVS and the Bernalillo County Assessor's Office hosted a Veterans Benefits Outreach on December 16 at the assessor's office in downtown Albuquerque—a continuation of a third annual outreach collaborative outreach launched by the two agencies in December.

DVS Albuquerque-based Veterans Service Officer Gordon Schei (upper-left photo, in white shirt) and DVS Event Coordinator Joseph Dorn (middle photo, in dark shirt) joined Bernalillo County Assessor Office/Eligibility Specialist Carmen Gonzales (lower-left photo) to assist veterans with filing for the Veterans State Property Tax Exemption—a \$4,000 reduction in the taxable value of a veteran's primary residence. This benefit is also available

to un-remarried widows of veterans who would have otherwise qualified for this benefit.

Veterans rated at 100% service-connected disabled were able to have their total property tax liability waived.

A new feature for this joint collaboration is the ability for veterans to receive their Property Tax Exemption Certificate from Mr. Schei on the spot—allowing them to forego having to return to DVS to pick up the completed certificate., or wait for it to be mailed to them in 2-4 weeks.

"The purpose of these collaborative outreach events is to streamline the veterans property tax exemption process," said Bernalillo County Assessor Tanya R. Giddings. "By having DVS on site, a veteran can also come meet with a

representative and learn about other state and federal benefits and resources available to them."





This joint effort continues through the spring, with outreach stops at the Bernalillo County Assessor's Office on February 20, March 19, April 16, and concluding on April 23.

No appointment is necessary. Veterans must bring a copy of their DD-214 separation papers or any documents from the VA as proof of veteran status in order to receive the veterans' property tax exemption certificate, or to help expedite any on-site filing veterans' benefits processes.

Veterans can also file for lost DD-214's.

Veterans anywhere in the state can also simply contact their nearest DVS field office listed on the back two pages of this newsletter to file for their the veterans' property tax exemption—or their VA or state veterans' benefits.

DVS Gives First Quarterly Briefing of the Year

DVS presented its first quarterly briefing of 2020 on January 22 at the New Mexico Veterans Memorial in Albuquerque.

These briefings provide an opportunity for DVS, the New Mexico VA Health Care System, the Albuquerque VA Regional Office, and selected veterans service agencies or community partner organizations to talk about ongoing or planned activities.



DVS Deputy Secretary Bryan Osterhage moderated the briefing in place of Secretary Judy Griego—who was called to a Cabinet briefing with Governor Michelle Lujan Grisham. He began the proceedings with a presentation of the New Mexico Medal of Merit, on behalf of the Governor, for meritorious achievement in helping veterans, to Joe Baca (*left photo*), the Congressional Liaison to New Mexico VA Health Care System (NMVAHCS) Director Andrew Welch; and to Mitchell Lawrence (*below photo*), the former DVS Health Care Division Director now working with the NMVAHCS.

The certificates, in part, recognized the two for their work with DVS, and their "...professionalism and dedication to New Mexico's veterans, which has been a positive influence in the lies of countless veterans. Mr. Baca/Mr. Lawrence has exhibited outstanding leadership, dedication, and selfless service...which reflects great credit upon himself and the New Mexico Department of Veterans Services."



The New Mexico VA Health Care Center (NMVAHCS)

NMVAHCS Director Welch then gave an update from the Albuquerque Raymond G. Murphy VA Medical Center. He began with a report on the Fisher House, which opened last October to provide free lodging for families of veterans undergoing inpatient care at the medical center and who live outside of the Albuquerque metro area.

He thanked the many agencies—including DVS—for supporting the Fisher House Foundation's effort to build the facility on the VAMC campus.

"It is a beautiful facility. What we have is comparable to any 5-star hotel in the state," said Director Welch. "Ten of the 16 suites are now occupied, and we anticipate regular full occupancy as word of this fantastic facility spreads throughout New Mexico."

Director Welch also re-emphasized the NMVAHCS commitment to tacking the problem of veteran suicide, which he said is the top priority of the VA nationwide. He cited the latest VA data which shows an average of 20 veterans a day take their own lives. Of these 20, Director Welch said 14 are not VA patients; of the remaining six, three skip their regular treatment.

"If anyone says suicide prevention is not treatable—they are wrong," he said. "We know that once we get hold of them, their chances of success are very high, because our programs work. But we need your help in finding these veterans who need help."

Director Welch concluded his update with a reminder that, as of January 1, the VA has now begun reviewing claims by Vietnam War "Blue Water Navy Veterans" for Agent Orange-related health problems. He urged these Vietnam War Navy veterans to submit claims if they haven't done so, or to refile a claim which was previously denied.

NM National Guard

New Mexico Army National Guard Maj. Randall Bates followed with an update from the New Mexico National Guard (NMNG). He spoke on behalf of New Mexico Adjutant General Ken Nava, who like DVS Secretary Griego was also in Santa Fe for the 2020 Legislature.

Maj. Bates supported NMVAHCS Director Welch's commitment to dealing with veteran suicide--pointing out that all NMNG personnel must take a mandatory 1-1/2 hour suicide prevention class, and that the NMNG offers an additional two-day optional class.



"These are something that we really push out," said Maj. Bates. "The New Mexico National Guard strongly believes that one loss of life...is one too many."

He then gave an update on troop deployments:

- Nearly 400 NMNG soldiers of the NMNG's 1st Battalion/200th Infantry are now in the Horn of Africa region in support of ongoing U.S. operations countering piracy and other militant activity.
- A medical unit of 65 soldiers of the 1209th Medical Support Company is in Poland in support of Operation Atlantic Resolve, which monitors tensions between Russia and Ukraine.
 - Maj. Bates reported that Maj. Gen. Nava and NMANG State Command Chief Mitchell Brush recently returned from visiting the troops in both regions.
- A five-man unit will be heading to Kuwait this fall in support of ongoing U.S. transportation operations in that region; with another unit deploying to Kuwait this fall.

Maj. Bates concluded his briefing with a report on the New Mexico National Guard's Emergency Relief Fund...which was created two years ago through legislative action to create a source for emergency funds for Guard members who encounter difficulties paying for rent/mortgage, utilities, home repairs, and other financial hardship cases.

The Fund was initially allotted \$160,000. To date, \$73,000 has been utilized by 36 Guard members:

- \$27,000 in rent/mortgage assistance
- \$8,000 home repairs
- \$3,000 utility bills

With the recent and future planned troop deployments, Maj. Bates said the families of these deployed Guard personnel may be at risk for financial difficulties. He asked those in attendance to spread the word about this fund—and how people can contribute to the fund:

- Designating all or part of a state income tax refund on the tax forms
 - And the need to fill out a Personal Income Tax Form "D"
- Making direct donations to the fund.

<u>Central New Mexico Community College (CNM)</u> Veterans Resource Center

CNM Veterans Resource Center (VRC) Coordinator Matthew Fuentes gave a presentation about the VRC and its role as a great source of information and assistance for veterans enrolled at the college.



The VRC, he said, provides a welcoming environment which can help veterans with everything from academic counseling, GI Bill® issues, tutoring, career counseling, help with applying for four-year or even Master's degrees, applying for additional financial aid, housing and transportation assistance. He also said the VRC also offers a place for veterans to just "hang out" before/between/after classes...with fellow student-veterans.

According to Mr. Fuentes, 1,036 veterans are using their GI Bill® at five CNM campuses and five additional affiliated locations. He also said later this year—for the first time—CNM will hold a separate "Veterans Graduation" ceremony apart from the "general" graduation ceremony. UNM-Taos Upward Bound Program

Following Mr. Fuentes was a brief presentation from Leonard Shephard, the Outreach Coordinator for the UNM-Taos Upward Bound Program. The federally-funded program is the only veterans federal TRiO program funded by the U.S. Department of Education in New Mexico for veterans who want to use their GI Bill® to attend a college or university—but may need a "refresher" course or "jump start" before applying.

Though affiliated with UNM-Taos...and housed at the CNM VRC...the program can help veterans who want to attend any college or university

in the state. Applicants must have been deployed on active-duty for 181 days or more, discharged at other than dishonorable, be from a low-income family, a "first-generation" college student (parents do not have college degrees), and show a need for academic support to successfully pursue a post-secondary education. VA Releases Updated DOD List Identifying Agent Orange Sites Outside of Vietnam

The U.S. Department of Veterans Affairs (VA) released in January an updated Department of Defense (DOD) list of locations outside of Vietnam—including several locations here in the U.S.: www.publichealth.va.gov/exposures/agentorange/locations/tests-storage/outside-vietnam.asp where tactical herbicides were used, tested or stored by the United States military.

"This update was necessary to improve accuracy and communication of information," said VA Secretary Robert Wilkie. "VA depends on DOD to provide information regarding in-service environmental exposure for disability claims based on exposure to herbicides outside of Vietnam."

DOD conducted a thorough review of research, reports and government publications in response to a November 2018 Government Accountability Office report: https://www.gao.gov/assets/700/695490.pdf

"DOD will continue to be responsive to the needs of our interagency partners in all matters related to taking care of both current and former service members," said Defense Secretary Mark T. Esper. "The updated list includes Agents Orange, Pink, Green, Purple, Blue and White and other chemicals and will be updated as verifiable information becomes available."

Veterans who were exposed to Agent Orange or other herbicides during service may be eligible for a variety of VA benefits, including an Agent Orange Registry health exam, (https://www.publichealth.va.gov/exposures/agentorange/benefits/registry-exam.asp), health care, and disability compensation for diseases associated with exposure. Their dependents and

What is Agent Orange?

Agent Orange was a tactical herbicide used by the U.S. military from 1962 to 1975, named for the orange band around the storage barrel. The military sprayed millions of gallons of Agent Orange and other tactical herbicides on trees and vegetation during the Vietnam War. Several decades later, concerns about the health effects from these chemicals, including dioxin, a byproduct of Agent Orange production, continue.

The VA offers eligible veterans a free Agent Orange Registry health exam (https://www.publichealth.va.gov/exposures/agentorange/benefits/registry-exam.asp) for possible long-term health problems related to exposure. The VA also offers health care, disability compensation, and other benefits to eligible veterans for certain disease conditions, as well as benefits for children of Vietnam veterans who have Spina Bifida. Dependents and survivors may also be eligible for other benefits.

VA Makes it Easier to Use the VA Home Loan Benefit

On Jan. 1, 2020, it became easier for veterans use their VA home loan benefit to purchase, refinance, or construct a home with no down payment, regardless of the cost of the home.

The VA home county loan limits were eliminated as part of the Blue Water Navy Vietnam Veterans Act of 2019 for veterans and service members with full entitlement. Historically, the VA only guaranteed home loans up to the county conforming loan limits (CLL) as determined by the Federal Housing Finance Agency. These loan limits reflect the changes in average U.S. home prices at the county level.

If you chose to purchase, refinance, or construct a home above the CLL, the lender would likely require a down payment from you before they would choose to close on the loan. In counties such as San Diego, Calif., or Arlington, Va., the limit is much higher to reflect the average cost of a home. This meant that when using your VA benefit, the lender—not the VA—would require you to pay up to a 25% down payment on any amount above the county limit.

As of January 1, first-time homebuyers, or homebuyers who have sold their home and have full benefit entitlement available, will no longer have to worry about loan limits or down payment requirements when purchasing, refinancing, or constructing a new home. Conforming loan limits will impact those who want to purchase a second (or subsequent) home using a VA home loan. For those that currently have a VA home loan and plan to keep it and purchase a new home using a VA-backed loan that is more than \$144,000, the rules are different.

- You must be able to afford all the loans at the time of closing.
- The next home you purchase must be your primary residence. The VA may be able to back the next loan, but it will depend on your *remaining entitlement* and the conforming loan limit (CLL) for your county.

Your basic VA home loan entitlement starts at \$36,000 and goes up to 25% of the loan amount. The amount remaining on your entitlement after purchasing your first home will impact how much of a down payment will be required for your next purchase.

If the county CLL is \$500,000 and your last loan was for \$500,000, then you have no entitlement remaining. If your first loan was for \$200,000 and the second is for \$400,000, the CLL for your next home would need to be at least \$600,000 if you want the no-down payment option, otherwise you'll have to pay a down payment on the amount above the CLL. Note that the county that will determine your loan limit is the county in which your next home is located.

As each case is different, your first step should be to request your certificate of eligibility (https://www.benefits.va.gov/homeloans/purchaseco_certificate.asp), which will show your remaining VA home loan entitlement. If you need assistance determining what this means for you, reach out to your lender or a VA loan specialist.

As with any home loan decision, you should speak with your lender(s) or a loan specialist at your VA Regional Loan Center (https://www.benefits.va.gov/homeloans/contact_rlc_info.asp) to go over your options when purchasing your next home. Only you can determine what is best for your personal and financial needs. Whatever the case, speaking to a loan professional about your options and shopping around for the best situation for you is key.

Applications Open for Community Organizations to Apply for Adaptive Sports Grants for Disabled Veterans

The U.S. Department of Veterans Affairs (VA) is accepting applications through March 17 for up to \$15 million in grants for civic groups providing adaptive sports and therapeutic recreational opportunities for veterans and members of the armed forces with disabilities.

Application instructions and eligibility information for these grants — which will help qualified organizations plan, develop, manage and implement these programs — are available at https://www.blogs.va.gov/nvspse/grant-program.

"Built on VA clinical expertise and operations, with essential support from community partners, the adaptive sports grant program allows the VA to extend its level of care beyond the clinical setting," said VA Secretary Robert Wilkie. "We are pleased to offer grant funds to community organizations, as it means there will be more veterans engaging in the challenge of sports and more Veterans who are exposed to new skills for healthier living."

In 2019, the VA awarded \$14.9 million in adaptive sports grants to 126 organizations, estimated to serve more than 11,000 Veterans and service members from every state, the District of Columbia and Puerto Rico. Of the total awarded, \$1.5 million is being used to assist organizations that offer equine-assisted therapy to support mental health. All applications must be submitted to www.grants.gov by 8pm EST on March 17. The VA will announce awards based on a competitive selection in fall 2020.

VA Launches Diabetes Education Campaign

The U.S. Department of Veterans Affairs (VA) has launched a new campaign to give veterans a better understanding of their diabetes numbers, which are critical to their well-being. The *Understand Your Diabetes Numbers* campaign educates veterans and their families on hemoglobin A1C, glucose meter, blood pressure and kidney tests, and other vital measurements.

"One in four veterans enrolled in VA health care services has diabetes," said VA Secretary Robert Willkie. "This public health campaign encourages veterans to be proactive with their health care teams by improving their understanding of diabetes test results. The campaign reflects VA's ongoing commitment to improve the health care experiences of Veterans by empowering them to be active partners in their care."

The <u>VA's Office of Patient Care Services</u> is overseeing the year-long campaign--which addresses treatment goals, medication and nutritional management, and patient safety. Key topics include understanding the importance of hemoglobin A1c test results, shared decision making between veterans and their health care team, <u>hypoglycemia safety</u>, insulin differences, good nutrition and carbohydrate counting, and kidney function and blood pressure measurement. <u>Hemoglobin A1c (HbA1c)</u> is a marker, along with blood pressure and cholesterol control, of good diabetes care.

VA's diabetes campaign is guided by Choosing Wisely® which is a collective effort among professional societies whose goal is to reduce medical tests, treatments and procedures that may be unnecessary.
