# **Department Wide Food Drive**

On Saturday, October 17, VFW and VFWA of New Mexico had a statewide food drive to help our local food banks. With the COVID-19 restrictions and closures, we have had limited access with our communities. Due to this problem, the Department decided to conduct a Department-wide food drive. This brought our Posts and Auxiliaries out into the public eye and showed that we are still doing lots for our communities, and veterans in particular. The joint food drive also had an incentive for our Posts and Auxiliaries, with \$500, \$300, and \$200 prizes to the top three from around the state.

Eleven Posts and their Auxiliaries participated on this project, from 10 AM - 4 PM. With combined donations of goods and money, a total of \$28,434.51 was raised. This was a great job for a first-time effort, considering New Mexico's social gathering restrictions of ten or less, and many community members were in financial trouble.

Here are the ways that Posts and Auxiliaries participated: Albuquerque 401 donated to the local school district; Santa Fe Post 2951 set up a tent outside the Post and unloaded dozens of cars making donations; Hobbs Post 3274 donated to a shelter for battered women and children; and the Grants Post donated to their local community pantry. Clovis Post 3280 teamed up with Walmart to arrange the delivery of multiple pallets of donated water; Rio Rancho Post 5890 asked their local food bank to bring a truck to their Post to collect donated items; Alamogordo Post 7686 welcomed members that were very excited and happy to participate, while Carlsbad Post 8703 donated to six different food banks in their city. Los Alamos Post 8874 paired up with the National Labs to receive donations and Los Lunas Post 9676 solicited their local paper to run an article about the food drive. In Las Cruces. Post 10124 held their meeting before the food drive to get the word out to their members, and the Department paired up with Enterprise Rent-a-Car to get donations at all Posts where an Enterprise was located in their city.

The winners of the food drive were as follows: 1<sup>st</sup> prize went to Post 8703 Carlsbad; 2<sup>nd</sup> prize to Post 5890 Rio

Rancho; 3<sup>rd</sup> went to Post 3280 Clovis. All the other Posts and Auxiliaries did outstanding work also, but these three were the top collectors of the Department. Congratulations to these three Posts and their Auxiliaries. To all of the Posts and Auxiliaries that helped in any way, you rock! And you prove that "No One Does More for Veterans Than the VFW." With this much food and money being raised by our Posts and Auxiliaries around the state, there will be many less hungry and needy families this holiday season. Keep up the great work, VFW and VFWA of New Mexico.

VFW Department Commander Cynthia Archuleta said "During these difficult times and all of the restrictions we have in place, this shows the community that the VFW never stops caring and giving to our communities. This is what the VFW is about, and we proved it again in one day what we can do during the worst of times. Thank you to all who participated. I am truly honored and proud of all of you. Thank you again for all your hard work." VFWA Department President Kandy Brazell said "A big thank you from the bottom of my heart for every VFW and VFWA member that contributed to the joint state-wide food bank contest! I know that the prize money was a great incentive to get out and collect nonperishable items for our food pantries, but as our members have the biggest hearts – I think that the overwhelming support that we had across the state would still have happened even if we didn't offer up the prize money. To all VFW Auxiliaries please report your contribution to this most needed charity event! I really hope that we do this again sometime in the spring or if we are able to have a mini drive at Mid-Winter!"

Santa Fe Post 2951's Commander Gilbert Romero said "This food drive is truly a testament to what people of good will can accomplish and it will remain a part of Post 2951's annual calendar," and Grants Post 3221 Commander Tyrra Saavadra said "VFW and Auxiliary are here to help the community any way we can."

Greetings, Comrades and Sisters,

# **Quartermaster Message**

Comrades, Adjutants and/or Quartermasters, please review the Monthly Compliance Report for the status of your Audits and Minutes of your Post sent to Department Headquarters in a timely manner. If there are not enough members for a quorum, just send a letter stating such.

REMINDER: All Community Activity Reports will be processed through www.nmvfw.org;

Login with Last Name and membership number, scroll to the bottom of the page and on the left side you will see the Community Activity Report link. This will collect all the data and provide a report to National HQ. This data has a large impact towards the selection of the All-State and All-American Teams.

REMINDER: The Post Quartermaster is the chief financial officer of the Post. The Quartermaster is the custodian of all Post property and the officer responsible for safeguarding Post funds and property. The Quartermaster is accountable to the Post, Department, and the National Organization, for all of the monies, securities, vouchers and property of the Post. The Quartermaster is the only one authorized under the By-Laws, to receive, handle, disburse and account for funds

of the Post. There are no exceptions to this rule! No committee, holding company, canteen manager, group or individual in the Post or in any way connected with the Post's activities, can take this authority and responsibility from the Post Quartermaster. All funds, monies or property accumulated under the name of the Veterans of Foreign Wars for the Post, regardless of the Meetings. These should be nature of the activity which accumulates them, are the property of the Post and are subject only to disposition by Post action. No Post member can mandate the expenditure of funds or disposition of Post Property unless properly authorized by the Post and executed by the Quartermaster.

Section 218 (a) (5) (h) of the Manual of Procedure

The books and records of the Quartermaster shall be maintained in a legible and uniform format. Record keeping by electronic means may be used, provided a back up and a hard copy is maintained. Books and records shall be available for inspection by authorized officers and Post members' at all reasonable times. Reconcile and verify all transactions listed on all bank statements to assure the accuracy of post records. Unless authorized by the Post to remove such books and records from its facilities, all such books and records shall be kept at the Post facilities







VFW Post 2951, along with everyone else, is being critically affected by the current COVID-19 Epidemic which prevents us from doing our normal fundraisers that allow us to pay required operating bills and utilities. "The fact that we are treated as a bar is hurting the mission of the VFW," said Gilbert Romero commander. "We are a canteen in our Post home. We're not a bar,

and having us classified as that prevents us from accomplishing these other vital services that we provide to the community."

Like many VFW chambers, VFW Post 2951 serves as a local gathering place for veterans in the Santa Fe area, Romero said.

"It's become a center where veterans from this community can come to get away from daily life to interact and meet up with veterans who have experienced similar things in their past," he said. "[The center provides] respite from what can be sometimes an almost unfamiliar space in the world, ... [but] that has been removed as well because, again, our doors are shut, and we can't meet up and have that camaraderie ... with each other."

## **Post Pandemic Relief Grant**

Due to the recent Covid-19 pandemic, the VFW has faced previously unknown challenges throughout our entire organization, including at the local Post level. We realize that VFW Posts have been severely impacted in their ability to cover operating expenses through conventional means that have been hampered if not completely halted. To lessen the financial burden created by this unprecedented crisis, the VFW Foundation has earmarked \$680,000 for the VFW Foundation Post Pandemic Relief Grant (PPRG). Eligible Posts that own or lease their own Post Homes may apply for a grant of up to \$2,500. Requests will be reviewed, and if qualifying, approved in the order they are received by VFW Foundation staff. If approved, awards should be received within six weeks after submission.

#### **ELIGIBILITY**:

To qualify to receive this PPRG grant, a VFW Post must have completed any three out of the five following criteria during the 2018-2019 and/or 2019-2020 fiscal year:

- 1. Achieved 100% membership.
- 2. Submission of Voice of Democracy, Patriots Pen, and/or Teacher of the Year
- 3. Buddy Poppies purchased
- 4. Donation made to Veterans & Military Support Programs
- **5.** Reported 1,000 or more hours of community service to their Department
- **6.** Be in good standing (i.e. not on suspension)

with VFW National.

- 7. Own or rent a Post Home. The title deed or lease agreement must be held or signed by the members of the VFW Post. The building deed or rental must solely be in the name of a VFW Post and cannot be jointly owned or rented by any other veterans' group(s).
- 8. Have a fully completed Election Report on file with VFW National Headquarters. It is advised that a Post submit a copy along with their application to ensure expediency.
- 9. Have a combined total of less than \$10,000 in all non-restricted bank accounts held by the Post. Copies of the most recent statement for each non-restricted account must be submitted via email along with the application form.
- **10.** Agree to complete and return a two-page grant report form along with proof of how the funding was used.
- 11. Have a qualifying need, which includes payment assistance for the following: Mortgage/Rent; Utilities (gas, electric, water, etc.), Insurance; Property tax




