Judge Advocate Cathy Brock brought up that there is a section in the by-laws that we have been violating for many, many, years that need to take care of. That is in Article 6, Section 3, pertaining to the Department Convention and Mid-Winter Conference. Section 3 states (in the last paragraph):

"The Department Quartermaster shall set up a Department Convention Fund and all Department delegate registration fees received shall be placed therein and used and expended only for expenses incurred and expenditures made in the holding of an Annual Department Convention each year."

- QM Fouse responded that the line item has been in the budget for past 10 years
- Brock said it is not listed in the budget
- (NOTE: Refer to the 12<sup>th</sup> line item on the Estimated Income and line item 508 on Estimated Expenses. The entire chart of accounts is not listed due to the size of the end product and some are grouped together in a single category as reflected in Account 508. The Chart of Accounts does reflect those line items as mentioned in the Department By-Laws as does the Profit & Loss rep)

Some were registering at the hotel on the 3<sup>rd</sup> weekend and some on the 4<sup>th</sup> weekend. The Mid-Winter Conference will be held on the last full weekend in January

# MAKE THE NECESSARY CHANGE TO YOUR CALENDAR'S AND THE CALENDAR OF EVENTS IN YOUR COMMANDERS BOOKS ENSURE THIS IS BRIEFED AT DISTRICT AS WELL AS YOUR POST MEETINGS

Asst ADJ Karla Eaton briefed that the State Commander is holding the District Commanders responsible for the books

- Too many Posts never received a book last year and some years prior
- Ensure your individual Posts receive their book prior to the Flying Squadron
- Posts need to see the changes and they way we will be doing business

Motion by Sr Vice Mark Decker to keep the pre-registered rate at \$8.00 and raise the price at the door to \$30.00 because of the large amount of members waiting to register at the door. This convention we had 61 pre-registered and 65 register at the door. We need those numbers ahead of time. Want to make it so those will pre-register

- 2<sup>nd</sup> by Jr Vice Rich Nutt
- Discussion:
  - Jr Vice Nutt: what is the reasoning behind the \$30.00 vs. \$20 that was presented in the packets?
  - Decker responded: after sitting down with the QM and going over the monies; \$30 is hopefully a way to help get more members to pre-register. For several years, the QM has had to guess on many factors to include the amount of food, the number of seats to setup for each meeting etc. based on how many pre-registered members we have.
  - QM Fouse: Over the years, we have set precedence on allowing registering at the door, which was usually for those who didn't know if they would be able to get off work, etc...But, it has increased so dramatically over the years that we cannot predict how many meals to buy, seats to set up etc...We guarantee the hotel so many rooms, and a minimum amount that we have to spend on food and drink all before we ever show up at Convention or Mid-Winter. We are at a point now where the people at the door registering are larger than those who register beforehand. We are having to make a lot of difficult decisions based on assumptions. Sometimes we get it right, but most of the times we are off. Second options have been discussed and not to offer any meal tickets at the door to get our projections closer. This time we only had 42 meals pre-bought and a guarantee of \$5,000 in food and drink that we have to cover. This may be an incentive to register early.
  - Surgeon Roy Maldonado commented that this will create more problems by jumping the price to \$30 the amount might cause people not to attend and the conference will be smaller and smaller. I think \$30 is a high price and is a penalty not a solution. The solution is doing an accountability action prior to the event and then act on it.
  - PSC Hampton suggests raising the fee to \$20, for at least this year, and have a early bird registration drawing for discounts or something for everyone who has registered prior to a date to be set.
- Cathy Brock amends the motion to raise registration at the door to \$20.00 instead of \$30.00
  - Many of our members do not understand the difference between registration fees and convention delegate fees, and that is why they are not pre-registering. It is our fault for not explaining thoroughly
  - Post QM's are responsible for getting the delegate fees sent in.

- Motion on the Amendment Passed

Motion by Mark Decker to increase the cost of meals at the door to double the price

- 2nd by Rich Nutt
- Discussion:
  - Rich Nutt: For many years now, participation is declining. Biggest issue is
    the costs of the meals. By doubling the price of the meals bought at the
    door, no one will buy any meals at the door. Possibly cut off banquet
    sales 2 weeks prior and take create a buffer of a certain percentage to sell
    at the door, first come first served.
  - Cathy Brock commented, we are charging twice as much at the door, or if
    they buy them here, and we end up sitting with a batch of tickets left.
    Wouldn't it be better to get them to buy here and go to the banquet than
    sitting on a batch of unsold tickets left over where we already guaranteed
    the meals?
  - QM Fouse: We have to have a number for the hotel to know how many meals to purchase, how many meals to cook.
  - Brock: I would rather see any unsold tickets sold at the door than Department take the loss.
  - Maldonado: agreed the cost of the meals is the biggest issue. However, I caution that if we continue to increase, the numbers will not get any better. It's good to have some on hand to make something than nothing. (inaudilble)
  - QM Fouse explained the cost breakdown of the meals. On the lunch, there is the cost of the meal, plus 7% tax, plus a 22% service charge. Meal ended up costing close to \$30.00 and we sold for \$25 (\$15 with Dinner). We can't keep taking a hit on these losses. The prices are going to keep going up because of the economy, and will never come down. Something to think about.
  - Commander Eaton stated they have something in the works with the hotel.

- Cathy Brock moves to change the language of PA/Comm Officer to Public Relations Officer
