## "O Say Can You See"

In September, 2016 our Corrales, NM VFW Post 5432 was visited by Coach Eric Orell, from Manzano High School, Albuquerque, NM. Coach Orell requested our support in his program to teach his basketball team members how to properly honor the flag and veterans during the National Anthem that is played or sung at each game. He referenced the Virginia Tech Coach Buzz Williams, and provided us a link http://

insider.foxnews.com/2016/03/10/virginia-tech-basketball-players-get-lesson-veterans-national-anthem that allowed us to view what Coach Williams had done at Virginia Tech. Orell stated he had shown the video to his team, and was lining his

players up across court at each game so they could face the flag and pay proper respect to the flag and all veterans who have served our country. Coach Orell is an "Army Brat" and fully understands the meaning of respect to the colors. He wants his players to learn why they should not move or adjust clothing while the song is being played or sung; simply stand at attention with your hand over your heart and look at the flag. His team has bought into this, and does a fine job at games.

Coach Orell asked our VFW Post if it would help him in this effort by teaching his players about respect for veterans and what they have accomplished over the years. He knows that our age group grew up with different goals and objectives and under different leadership styles and wanted his team to hear our experiences. The players range in age from 14 to 17 years. We agreed to help him.

Orell felt that he could accomplish this effort by hosting a Sunday evening dinner in January, where we attended the meal and each sat with 2-4 players. Each of us wore slacks, casual dress shirts and our caps.

He is a long time member of the American Legion in Nashville, the Americal Division Veterans Association, and the Vietnam Veterans of America. John retired in October 2002 from the Tennessee Department of Veterans Affairs, where he served as assistant commissioner for 20 years, supervising 11 field offices.



# **Judge Advocate's Message**

Judge Advocate, I have been asked to review a number of actions taken by Posts and/or Commanders for compliance with VFW By-Laws and the Manual of Procedure. In many instances, my review determined that many of the violations could have been prevented if the Post and its Officers had taken the time to refer to the current Podium

In my position as your

Edition of the By-Laws. In the last five or six years there have been more than 1,000 changes approved by the National Conventions. If your Post Officers are using Podium Editions that are four or five years old, how can you possibly expect to have your Post Commander's actions upheld upon appeal? Not only the Commander, but the Quartermaster, the line officers and the Judge Advocate should get a copy of the new Podium Edition every year.

Each officer should become familiar with all of Article II-Posts in both the By-Laws and Manual of Procedure, and especially Section 218-Officers and

Chairmen, Duties and Obligations. How can the Judge Advocate fulfill his duties as the legal advisor if he doesn't have the current By-Laws, the Department By-Laws and the Post By-Laws?

Commanders, the Podium Edition should be your "Bible," and should always be readily available for you to refer to at any time. The By-Laws are not "Top Secret"...share them with any members who want to learn more about the workings of the VFW. Remember, the Post belongs to its members and it's the obligation of each and every member to protect the Post's Charter.

The old days of Posts "doing whatever they want, whenever they want" are long gone. If you don't follow the rules, you won't have a Post for long. Don't jeopardize your Charter...follow the rules! But, you have to know what the rules are so you can follow them. At least one copy of the 2017 Podium Edition should be available in your Post. If you have it, learn it, and order the 2018 Podium Edition as soon as it's available.

If I don't have the answer to your question, I will find the answer for you. Sometimes asking a question can save a whole bunch of problems later.

# **Delegates, Registration, and Convention Whys**

It is coming close to Department Convention time again. As one of the people that has worked the registration booth for the past few years at both Convention and Mid-Winter, we get asked the same question every year by many people. What is the difference between registration and delegation dues? Who pays for them? Why do we have to pay for both? Do we pay delegation dues at Mid-Winter?

So let's start with the easy stuff first. Registration dues are what it costs to attend the Conference and Convention. These are paid by the individual. The individual is responsible for paying this because they are the ones attending the meetings. They might or might not represent the Post, but are there to learn more for themselves. These dues go to the Department to help pay for the hotel, rooms, and extras the hotel provides for these meetings. The Department does not get any money from National or anywhere else to hold these meetings. So to keep the Department from going too far in the hole, they charge registration dues to everyone coming. The hotel gives the Department a discount for the meeting rooms, tables, and services we use because we have so many room nights booked for each meeting, and because we spend so much on food. So the more people that spend nights at the hotel for the meetings, and eat at the banquets, the less the Department has to spend out, and the cheaper the registration dues can be.

Now for the delegation dues. These are paid by the Posts for their representatives to be able to vote on resolutions, elections, and anything else that comes up. They are paid by the Posts because the person doing the voting is there to vote for the Post and are representing the Post. Delegate fees are set by the Department By-Laws and can only be changed by a By-Law change. This money goes to the Department to offset the cost of doing Department business at the meetings. The only time delegate fees are needed is for the Department Convention because this is the only time that delegates will vote to change By-Laws, elect officers, or do business at the Department level. Mid-Winter is a Conference and also a Council of Administration. The Council members (Commander, Sr. Vice Commander, Jr. Vice Commander, Quartermaster, Chaplain, Surgeon, Judge Advocate, Inspector, Chief of Staff, Immediate Past Commander, and all 8 Districts

Commanders) are the ones who vote at the Mid-Winter Conference and all Councils of Administrations.

So now that you know the differences between the two, you can see they are not the same thing, because one is for the Post to be able to vote and voice their opinion, and one is for the individual to learn. This is why there are two different sets of dues. There is no way that someone can pay their delegate fee and not register for the meeting. If you go to the meetings, you will learn to differentiate these things for yourself. The bottom line is that **you** will have to pay your registration fee, while the Post is required to pay for the delegate fees of one delegate per 35 members, or part thereof.

The next question we are asked is this: why does the Department want everyone to pre-register? Pre -registration is required because the hotel needs to block off the correct numbers of rooms for both nights to accommodate our attendees, and they need to be prepared to accommodate our meal needs about a month in advance of the event. This is the number that the hotel uses to set a price to the Department. If we do not have enough food or room nights sold by this cutoff date, the Department gets charged more. Plus, when it comes time for the meals, the amount of food we had ordered is what they will have prepared. So people that register at the last minute, or at the door, or make reservations at the hotel after the cutoff date, are good and welcome, but do not help us with our minimum number of required expenses. Also, having as many as possible pre-registered ahead of time cuts down on the problems of registering at the same time. In this way, we can then make sure we have enough chairs and rooms for all of the meetings, and booklets for all the attendees, etc.

I hope this article helps explain some of the questions attendees have about the Department Convention and Mid-Winter Conference. We are always willing to answer your questions one-on-one if you need more explanation. If you have other questions, please do not hesitate to ask any of the Department Line Officers or anyone at the registration booth. We look forward to seeing you at Convention and hope it is successful and enjoyable for everyone.

The Final 2015-2016 Budget was approved and the 3-month Report for the 2016-2017 year was approved. Also the audit as of August 31, 2016 was approved.

Amendments to the VFW Auxiliary National Standing Rules were approved with a minor addition/clarification.

The Resolutions Committee presented an overview of the Resolutions that have been submitted to date:

- Department of Delaware Resolution to delete citizenship requirement for membership
- Department of New Hampshire Resolution to credit former members of the Men's Auxiliary with time in that organization
- Department of Washington Resolution to allow Auxiliaries to obtain and use debit/credit cards
- Department of Mississippi Resolution to change Auxiliary Suspension to Auxiliary Review

- Department of Wisconsin Resolution to move the location of pin on the official look to the other side of the blouse/shirt.
- Department of New Mexico Resolution to allow Auxiliaries to obtain and use credit card

Note that these resolutions will be available on the National website after April 1, and will not be considered until the 2017 National Convention. So, it would be prudent for you to read them completely, discuss them in your Auxiliaries, and convey your opinion to your delegates. Keep in mind that if you should convey your opinions to your delegates, but don't tie their hands by forcing them to vote a certain way. Delegates should be trusted to use their best judgment when voting as when matters are discussed, opinions can change.

Later in the conference we also heard from the National Ambassadors. Here are just a couple of ideas from other departments that were shared:

- Americanism Get younger students involved in writing essays by holding an American Essay competition
- Hospital Collect items for "Distraction Kit" coloring books, colored pencils, Sudoku and crossword puzzle books; recognize your hospital volunteers
- Scholarships Bring the previous department Voice of Democracy winner to your Voice of Democracy awards banquet
- Membership Personal contact is key to getting members to renew
- St. Patrick's Day Goal Get to 100%

# **Scouting Requirements**

Annually, the Veterans of the Veterans of Foreign Wars of the United States awards three individuals who are: Eagle Scouts, Girl Scout Gold Award recipients, Venture Summit Award recipients and/or Sea Scout Quartermasters who have risen above their peers in exemplifying the qualities of that rank. National awards are as follows: \$5,000 1<sup>st</sup> place, \$3,000 2<sup>nd</sup> place and \$1,000 3<sup>rd</sup> place.

I encourage VFW Posts in New Mexico to sponsor exemplary Scouts from their communities for this honor. Your Post can sponsor a scout regardless if the Scout is chartered by your Post. In other words, if your Post does not charter (sponsor) a Scout Troop, your Commander may still sponsor a Scout for this award. Each year in New Mexico, an exemplary Scout is selected to receive the NM VFW Scout of the Year \$500 Scholarship Award. In 2014, an Albuquerque Girl Scout Gold Award recipient received the NM VFW Award. In 2015, an Eagle Scout from Cloudcroft and in 2016 an Eagle Scout from Farmington received the VFW NM Award. Each recipient of the VFW NM Award is entered in the VFW National Award competition.

### Eligibility:

- Be registered, active member of a Boy or Girl Scout Troop, Venturing Crew or Sea Scout Ship.
- Be the recipient of the Eagle Scout Award, Girl Scout Gold Award, Venture Summit Award or Sea Scout Quartermaster Award.
- Have demonstrated exemplary citizenship in school, Scouting and community.
- Have reached his or her 15<sup>th</sup> birthday and be enrolled in high school or home schooled at the time of selection

The nomination submittal must be filled out by the Scout, and turned into a VFW Post who will serve as his/her sponsor. A Post may receive more than one nomination. Deadline for entry to a VFW Post is March 1. One candidate with full entry criteria can then be submitted by a VFW Post to me, the NM Department Scouting Chairman by April 1. VFW New Mexico will select the youth who has risen above his/her peers exemplifying the qualities of that rank, and send the winner's nomination submittal to National for their judging.

The nomination forms can be found on the VFW

National website, <a href="www.vfw.org">www.vfw.org</a>, or you can contact me for a copy.

The following documentation should be submitted to the local Post by the scout:

- Photograph of the Scout
- High School Participation Record
- Scouting Record
- Community Service Record
- Letters of Recommendation
- Completed Entry Form

The paperwork and nomination form must be filled out by the Scout. I encourage you to announce this award to your Boy Scout Council's and with Scoutmasters in your community. The dates for this award are set by the national VFW and are rigidly followed. A team of VFW members who are Eagle Scouts serves as jurors for VFW New Mexico Award.

# **2017 Boy Scout of the Year Competition**



Eagle Scout Benjamin Curnutt of Troop 178 in Las Cruces, was selected to receive the Department of New Mexico VFW's prestigious Scout of the Year \$500 Award. He was nominated by VFW Post 10124 of Las Cruces, and his nomination will be entered in the VFW National competition. Benjamin has earned 30 merit badges and served as his troop's Senior

Patrol Leader, Chaplain Aide, and Team Secretary. He is the recipient of the 100 Mile Award from Philmont Scout Ranch, and has attended Florida Sea Base, where he crewed on a sail boat on the Atlantic Ocean.

**ABOUT THE SCOUTING PROGRAM** Scouts who are registered, active members of a Boy or Girl Scout Troop, Venturing Crew, or a Sea Scout Ship who have received the Eagle Scout Award, Girl Scout Gold Award, Venture Summit Award or Sea Scout Quartermaster Award are eligible for the Scout of the Year Award. Scouts must be 15 years of age and have demonstrated practical citizenship in school, scouting and the community. Scouts must be enrolled in high school at the time of selection. Note: All applicants still in high school who reach their 18th birthday during the nomination year remain eligible if otherwise qualified.

**HOW TO ENTER** Scouts should download and submit a completed VFW Scouting Scholarship form, resume of high school activities, scouting record, community service record and letters of recommendation to a local VFW Post no later than March 1. Note: A Scout can enter through one (1) VFW Post only.

**HOW IT WORKS** Local VFW Posts submit all candidates with full entry criteria to their respective VFW Department (state) by April 1. From there, the Department selects a winner and forwards the entry to the VFW National Headquarters by May 1 for national-level judging.

**HOW TO** Eligible Scout of the Year applicants are normally submitted by individual units. It should be remembered that the VFW is not the only organization seeking to recognize these young people.

The ideal process is for Department of NM Posts to select and recognize a Scout of the Year. Following the selection of Scout of the Year by Posts, and if practical, a District level judging should be conducted. Again, the winner should be recognized at a Post/District meeting and the application forwarded to me for the Department judging process.

The Department judging for New Mexico is done by at least two Eagle Scout VFW Members. One of the jurors who has consistently served as a judge is Seth Orell, Commander of VFW Post 5432 in Corrales. We often receive 5 to 6 submissions a year from Posts across New Mexico. Recognition for the Department winner is normally held during the Department Annual Convention generally held in June. This is a great opportunity for the Scout to see the VFW in action. If anyone has questions about this process, please call.

### **VFW Records Retention**

The Veterans of Foreign Wars has specified records that must be kept for certain times. Many Posts, Quartermasters, and Adjutants are unsure of these times.

Please use the following list as your guide for what records you need for certain timeframes.

- For 1 year after fiscal year: Postal records.
- For 2 years: Audit reports periodic, bills of lading, financial reports periodic, freight claims, income statements periodic, periodic financial reports, and shipping and receiving documents.
- For 3 years: Community activity reports, correspondence general, entertainment gift and gratuity records, freight bills, inspection records, labor cost records, and petty cash records.
- For 3 years after termination: Bonds fidelity and surety, and lease records.
- For 4 years after termination: Employee records, and insurance records general.
- For 5 years: Audit work papers, balance sheets, bank deposit slips, bank statements, budgets, election of officer reports, membership rosters, Post minutes (note 2), and quartermaster reports (note 3).
- ◆ For 7 years: Accounts payable invoices, accounts payable ledger, accounts receivable ledger, employee withholding records, cancelled checks, cash receipt records, employee

- termination, expense vouchers, and payroll register.
- For 7 years after termination: Contracts, employee contracts, and garnishments.
- For 10 years: Audit reports annual and correspondence executive.
- For 11 years after termination: Employee insurance records
- For 30 years after settlement: Employee accident reports.
- Permanent: Annual financial report, certified annual financial statements, depreciation schedules, general ledger, income statements annual, incorporation papers, inventory records, membership applications (note 1), property records, and tax records.
- Continuing: Annuity and deferred payment plans.
- Until superseded: By-Laws

Note 1- Membership applications should be used for establishment of eligibility, length of membership, and historical value.

Note 2- Keep minutes that are for policy decisions longer if policies have not been incorporated into By-Laws.

Note 3- Monthly Quartermaster reports are dead files after quarterly audits are done. But recommended kept in case of a detailed reconstruction is needed.




