## A Time to Remember and Thank Veterans On National Vietnam War Veterans Day



VIETNAM WAR

March 29

March 29 is National Vietnam War Veterans Day, established as an observance in 2017 to honor the service and sacrifice of Vietnam War Veterans. This day coincided with the withdrawal of U.S. military units from South Vietnam on March 29, 1973. It is a day meant to pay tribute to veterans of the Vietnam War, including personnel who were prisoners of war or who were listed as missing in action. We make no distinction between Veterans who served in-country, in-theater, or who were stationed elsewhere during the Vietnam War. All were called to serve, and none could self-determine where they would serve.

U.S. involvement in Vietnam started slowly with an initial deployment of advisors in the early 1950s, grew incrementally through the early 1960s, and expanded with the deployment of full combat units in July 1965. The Department of Veterans Affairs (VA) estimates that, today, there are between 6 and 7 million U.S. Vietnam Veterans living in America and abroad, along with millions of families of those who served during this timeframe.

Remember to thank your family members, friends, and neighbors who served in the Vietnam War for their service and sacrifice.

On June 28th, 2024, the New Mexico Department of Veterans' Services (NMDVS) dedicated the half-scale replica of the Vietnam Memorial Wall at the Vietnam Veterans Memorial in Angle Fire. Like the national wall, the replica wall features black granite panels engraved with the names of the 58,000 fallen U.S. service members from the war, including 398 New Mexicans.

Today, the Memorial includes a visitor center, museum, memorabilia displays, and artwork that provide a glimpse into the daily lives of our troops. It also includes an amphitheater, a memorial walkway, gardens, and a Huey Helicopter display. The Memorial overlooks the Angel Fire State Veterans Cemetery and sees approximately 45,000 visitors each year.



# Military and Veterans Day at The New Mexico Legislature

On February 19th, 2025, Military & Veterans Day at the New Mexico State Capitol Legislature honored military Veterans, National Guard members, reservists, and active-duty service members. This year's theme, "Enduring Legacy," highlighted the lasting impact of military service across generations.

The Capitol Rotunda ceremony was a profound expression of respect and gratitude, honoring New Mexico's enduring military legacy and recognizing the families of past, present, and future service members. Valdemar De Herrera, at 105, the oldest survivor of the Japanese POW camps of the Bataan Death March during World War II, was honored. Due to health concerns, Juanita De Herrera Clements and Nancy DeHerrera Crochet accepted the honor on their father's behalf.

Representing the future was New Mexico National Guard Member Private First-Class Analisa Toledo, who had just graduated from basic and infantry training. New Mexico Senator Shannon Pinto was recognized for participating in the 2024 Forgotten Heroes Burial Ceremony. Cabinet Secretary Jamison Herrera presented Senator Pinto with a flag from the ceremony, a symbol of our deep respect and gratitude toward our Veterans.

The event featured interactive and informative tables and displays from the Department of Veterans' Services, the New Mexico National Guard, the VA, and various community service organizations throughout the day.

## New Mexico Civil War Veteran Honored with Headstone

James Santiago Taylor, a former Clapham, Union County, New Mexico resident, was honored on Valentine's Day at the Clayton Memorial Cemetery with a marble military headstone to honor his service in the Civil War. This event not only paid tribute to Taylor's service but also connected us to our local history. His family, who has been in the Clayton area for seven generations, has a deep-rooted connection to our community. James Santiago Taylor arrived in the United States from England in 1863 and was a part of the Troop H, 3<sup>rd</sup> Regiment Colorado Calvary in 1864. After his service, he relocated from Colorado to Clapham and was a first-generation resident of Union County. He married Maria Apollomia Truillo in 1864 and together they had eleven children.

James Santiago Taylor arrived in the United States from England in 1863 and was a part of the Troop H, 3<sup>rd</sup> Regiment Colorado Calvary in 1864. After his service, he relocated from Colorado to Clapham, then Clayton, before passing in 1891.

Great Grandsons Sam, Michael, and Jimmie Taylor have worked together for over a year to grant their Great Grandfather James a Military headstone. David Walker, New Mexico Department of Veterans' Services (NMDVS) Bureau Chief of the State Veterans Cemeteries and Memorial Program, assisted in making the headstone a reality. The 1800s design was facilitated by working with the National Cemetery Administration with the help of Stephen McConnell, Interment Specialist Supervisor at the Ft. Stanton New Mexico State Veterans Cemetery.

With a deep commitment to honoring our Veterans, the NMDVS State Benefits Division operates three state Veteran cemeteries. Their dedicated assistance ensures that families can rest assured that their loved ones, including eligible dependents, will have an honorable final resting place.

## March is Women’s History Month

In March, we honor women's history in and out of uniform. Although women have served in the military since 1948, Women's History Month wasn't officially recognized and celebrated until 1987. From the battlefields of the American Revolution to the deserts of Kuwait, women have served in the military in one form or another for more than 200 years. They have had to overcome decades of obstacles to achieve their status: serving in greater numbers, combat roles, and leadership positions worldwide.

Our nation's female Veteran population reflects the increasing number of female service members. According to the VA, there are over two million female veterans, constituting 11 percent of our nation’s 18.5 million Veteran population. In New Mexico, nearly 11 percent (16,600) of our state’s 144,997 Veterans are women, a significant and growing presence. Women today, in March and throughout the year, continue to make significant contributions to the Armed Forces, adding to their rich legacies and shaping the future of our military.



NMDVS ensures that women Veterans and their eligible dependents know about available state and federal benefits and have equitable access to Veteran programs and services through the Women Veterans Program, which advocates for women and their needs.

## March 25th is National Medal of Honor Day

National Medal of Honor Day, observed annually on March 25th, is a tribute to the brave recipients of the Medal of Honor. This prestigious award, presented by each branch of the U.S. military, is reserved for those who have demonstrated exceptional courage and selflessness, often at great personal risk, in the face of enemy action. Their actions must have been performed 'conspicuously by gallantry and above and beyond the call of duty.

The first Medals of Honor, a symbol of unparalleled bravery, were awarded on March 25, 1863. This historic event marked the beginning of a tradition that continues today. When Congress passed a resolution in 1990 establishing National Medal of Honor Day, March 25th became the official nationwide holiday to honor the medal and its recipients and connect us with our rich military history.



The Medal of Honor, an award of unparalleled significance, is bestowed only upon the most deserving military members. It is also known as the Congressional Medal of Honor. National Medal of Honor Day is a time to reflect on the sacrifices of exceptional military personnel who have earned this highest honor.

## Why Veterans Should Use NMDVS for Benefits

### Why Veterans should consult with a New Mexico Department of Veterans' Services (NMDVS) VSO.

Veterans and their families deserve the full range of benefits they've earned through their service, but navigating the VA claims process can be complicated. From filling out paperwork to understanding eligibility, it can often feel overwhelming. That's where a Veteran Service Officer (VSO) can make all the difference.

#### 1. Free of Charge Assistance

The Department of Veterans Affairs does not charge any fees for a VSO's assistance, making it an invaluable resource for those seeking to access their earned benefits. Veterans can receive professional guidance, support, and advice without worrying about hidden costs or expenses. Ensuring your claims are handled efficiently and accurately is a no-risk opportunity.

#### 2. VA Accreditation

Veteran Service Officers are accredited by the Department of Veterans Affairs (VA), which means they have met strict qualifications and adhere to a high standard of training. This accreditation ensures that VSOs are knowledgeable and authorized to assist veterans in filing claims and accessing benefits. Accredited VSOs have a deep understanding of the VA's regulations and guidelines, making them uniquely qualified to navigate the often-complex VA system on behalf of veterans.

#### 3. Experience with Claims Laws and Processes

The VA claims process can be a maze of paperwork, deadlines, and regulations that are difficult to understand without experience. VSOs bring years of hands-on experience working with veterans and their families to guide them through the claims process. They stay updated on changes to laws, policies, and requirements, ensuring that the veterans they serve have the most up-to-date information.

The New Mexico Department of Veterans Services (NMDVS) provides support and services for New Mexico's veterans and their families. NMDVS treats every veteran, regardless of their rank achieved during military service, with the respect and gratitude befitting someone who has served our country. ## Upcoming DVS Veterans' Benefits Outreach Visits

DVS is scheduled to make the following January and February outreach visits at the locations listed below. Please bring a copy of your DD Form 214 Certificate of Release or Discharge from Active Duty, which are necessary for filing all Veterans' benefits claims. DVS can help assist veterans file for lost or misplaced DD 214s.

# Upcoming NMDVS Veterans' Property Tax Exemption Events

Both proposed Veterans' Property Tax Exemption Amendments 1 and 2 were passed during the November 2024 General Election and are now undergoing the legislative approval process for enactment. At this time the exemption has passed the State House and is waiting to be heard in the Senate Tax, Business and Transportation Committee. NMDVS and the TAX REV department will collaborate closely with the County Assessor's offices to develop and implement rules for the upcoming 2025 tax exemption changes.

A revised NMDVS DVS-1 application will be introduced with a new disabled percentage rating certificate for implementation. As soon as the rules process is approved for implementation, information on when to apply for the new certificate will be announced.

## What will change for the 2025 Property Tax Exemption?

**Amendment 1** changes the New Mexico Constitution to extend the existing property tax exemption for 100% disabled Veterans and their widows and widowers. This extension now includes veterans with less than 100% disability and their widows or widowers. The exemption amount is based on a Veteran's federal service-connected disability rating, as determined by federal law.

**Amendment 2** changes the New Mexico Constitution to increase the Veterans' property tax exemption for honorably discharged members of the armed forces and their widows or widowers from **\$4,000 to \$10,000**. The amount will then be adjusted for inflation after 2025.

NMDVS will keep you updated on the process and has scheduled veteran property tax exemption events throughout the state to explain the changes for the 2025 tax year. DVS will also have Veteran Service Officers (VSOs) on-site to assist Veterans and their eligible dependents with filing VA claims and obtaining federal and state benefits.

Our VSOs also help connect veterans to vital community resources, such as transitional housing and medical and behavioral health care. Information and assistance on federal and state benefits, local Veterans' programs, and referral services are available at any of our field office locations.

## The New Mexico Veteran’s Business Outreach Center (VBOC)

The VBOC is funded by a U.S. Small Business Administration (SBA) grant managed by DVS to help Veterans, transitioning active service members, National Guard & Reserve members, and their spouses who are interested in starting or growing a small business. It can help with everything from business planning, start-up and expansion funding, marketing, landing federal contracts, and anything else a small business needs to launch and grow.

DVS was the first state agency in the nation funded by the SBA to offer this “one-stop-shop” when the SBA launched this grant program in 2010.

## News from the U.S. Department of Veterans Affairs (VA)

### Health Impacts of Chronic Stress and How to Manage

For many people, everyday life can be both joyful and stressful. VA has launched a new campaign called "Stress Discussed" to better assist Veterans in managing stress for improved health. As part of this initiative, VA now offers a checklist for patients to complete before their scheduled appointments. This checklist helps patients identify their stress levels and facilitates discussions with their primary physician. Chronic stress can have a serious impact on both physical and mental health. Therefore, understanding and managing chronic stress is crucial.

New Mexico VA Health Care System Registered Nurse Deborah Meyer, who leads the Stress Distressed Campaign, suggests empowering Veterans with the necessary tools.

"If we equip our Veterans with knowledge about the symptoms related to stress, we can address the root causes of their stress rather than just managing the symptoms that might be contributing to their worries," said Ms. Meyer.

Effective Stress Management involves caring for your body and mind, practicing relaxation techniques, and connecting with others. There are also relaxation techniques, such as deep breathing exercises, progressive muscle relaxation, and biofeedback, which can help manage stress. Additionally, Veterans have access to community resources, including the Suicide and Crisis Lifeline. This service offers free and confidential emotional support and crisis counseling 24/7 by calling 9-8-8 (press 1 after the prompt if you are a Veteran). Engaging in self-care activities, such as pursuing hobbies, relaxation, and taking time for oneself, is also essential.

While stress can significantly impact health, with the right tools and support, Veterans can lead healthier, more balanced lives. The Stress Discussed campaign aims to empower Veterans to transform everyday stress into a more manageable aspect of their lives.

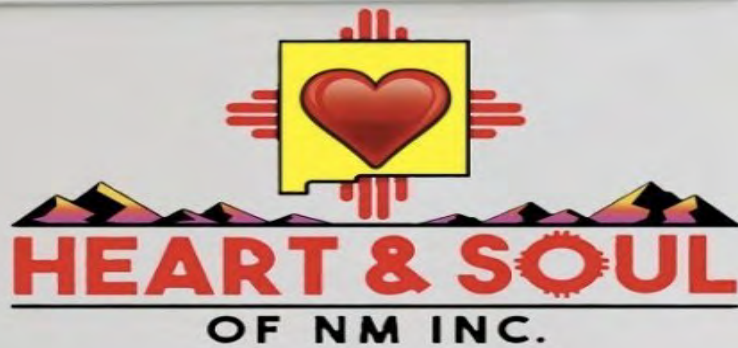

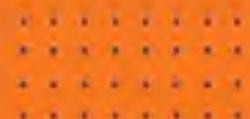
