## Military and Veterans Day at The New Mexico Legislature February 19th at the State Capitol



"Enduring Legacy" is this year's theme for honoring veterans and active-duty service members at the State Capitol rotunda. The New Mexico Department of Veterans' Services (NMDVS) and the New Mexico National Guard (NMNG) will pay tribute to New Mexico's veterans and military community members for their service and sacrifices for our state and country.

This event offers a fantastic opportunity for veterans, active service members, their families, and the public to meet legislators and discuss veteran-related issues. From 8am to 12pm, the rotunda will host information tables staffed by NMDVS, NMNG, VFW, DAV, the American Legion, veteran service organizations, and community partners. This is a great chance to learn about

services or benefits that you or your family members may not be aware of, but are entitled to.

The ceremony to honor our veterans and service members will begin at noon in the rotunda. This year, in recognition of New Mexico's enduring legacy of service, we will honor Valdemar DeHerrera, who at 105 years old, is our oldest survivor of the Bataan liberation. Valdemar's story of courage as a prisoner of war is both inspirational and moving.

Scheduled speakers include NMDVS Cabinet Secretary Jamison Herrera and NMNG Assistant Adjutant General Nathaniel Carper. We look forward to seeing you on February 19th on Military and Veterans Day at the New Mexico Legislature.

## DAV of New Mexico Stand Down at The Rock at Noonday

The Disabled American Veterans of New Mexico (DAV) hosted the 2025 Homeless Veteran Stand Down one-day event on January 17, at the Rock at Noonday homeless shelter in Albuquerque. The New Mexico Department of Veterans' Services (NMDVS), Paws and Stripes, VA Health Care Authority, Women Veterans of New Mexico, and many other organizations joined to identify and offer assistance and services to our homeless veterans.



The Rock serves over 85,000 plates of food to people without housing each year while providing a safe place to shower, receive clothing, and other essential services. According to the Veterans Administration (VA), nationally since 2010 veteran homelessness is down by 55.6%, however homelessness in New Mexico continues to be a major problem and finding our veterans through outreach events is a critical mission for NMDVS. On January 31, 2025, New Mexico Lieutenant Governor Howie Morales visited the Silver City office of the New Mexico Department of Veterans' Services (NMDVS). During this visit, he presented Veteran Service Officer (VSO) Clarissa Sierra with a Certificate of Appreciation in recognition of her exemplary efforts to assist New Mexico veterans in securing state and federal benefits. ## Remains of MIA Korean War Soldier from Los Lunas Identified.

On January 31, 2025, the remains of Army Pfc. Arthur A. Clifton, killed during the Korean War, were laid to rest near other family members also buried at San Antonio National Cemetery, San Antonio, Texas.

A native of Los Lunas, New Mexico, Clifton was a member of Headquarters Battery, 48th Field Artillery Battalion, 7th Infantry Division. He was reported missing in action on Dec. 11, 1950, at age 17, after Chinese forces attacked his unit as they attempted to withdraw near the Chosin Reservoir, North Korea.

On Aug. 19, 2024, Clifton was accounted for after analysis and identification by the Defense POW/MIA Accounting Agency, after his remains were exhumed in March 2021 from the National Memorial Cemetery of the Pacific.

The New Mexico Department of Veterans' Services sends condolences to the family and recognizes Clifton's sacrifice to our state and country.

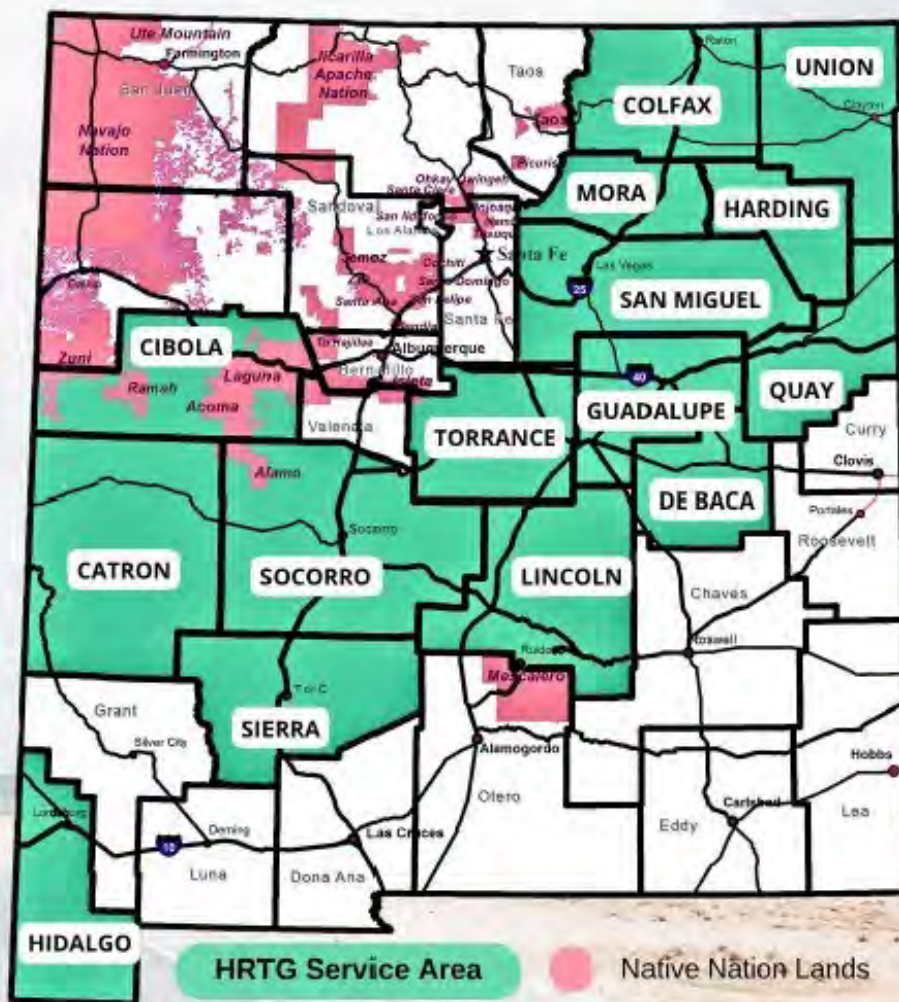
# HIGHLY RURAL TRANSPORTATION PROGRAM

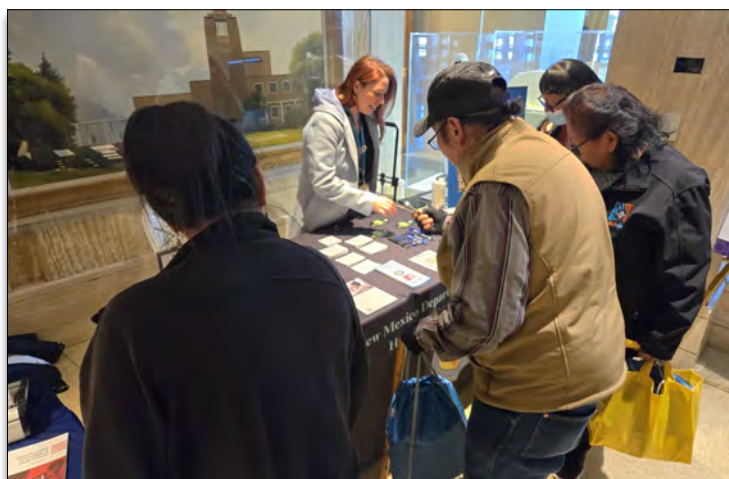
## Senior Day at the Legislature

On January 27th, 2025, seniors, caregivers, and advocates for aging services in New Mexico gathered at the capitol rotunda on January 27, 2025, to celebrate our senior community. The event saw strong attendance from various organizations dedicated to promoting positive changes for those aging in New Mexico. New Mexico Aging Services hosted the gathering, which plays an essential role in improving the lives of the state's aging population.

New Mexico Department of Veterans' Services (NMDVS) staff were available to answer questions and provide information on state and federal programs that benefit senior veterans. According to the 2015-2019 American Community Survey, there are over 18.2 million veterans aged 65 or older in the United States. These veterans served in conflicts across the globe, including World War II, the Korean War, the Vietnam War, and the Persian Gulf War. The Department of Veterans Affairs (VA) offers benefits and services tailored to address the various health risks and financial challenges they may face.

New Mexico offers a variety of benefits for senior veterans including property tax exemptions, education assistance, and transportation services. NMDVS provides free services to help veterans, and their families find and apply for benefits.

# American Indian Day at the Legislature

The Indian Affairs Department (IAD) hosted the annual American Indian Day at the State Capitol on February 7th, 2025. Tribal leaders, advocates, and performers celebrated “Tribal self-determination” on the day. During the event, Department of Veterans’ Services (NMDVS) Cabinet Secretary Jamison Herrera presented 100-year-old WWII and Korean War veteran Burton Platero with an award for his service to our state and nation.

Burton Platero was born August 8, 1924, in Canoncito, New Mexico, home to the To’hajiilee Chapter of the Navajo Nation. His family consisted of farmers and ranchers. He was active in community rodeos until grade 11, when he was drafted into the Navy at age 17.

Mr. Platero served in the U.S. Navy from November 1943 to December 1945 and in the Army Air Force/U.S. Air Force from October 1948 to August 1952. He primarily served on the USS Fremont attack transport ship during WWII. Mr. Platero participated in the landing at Saipan, Palau Islands, Leyte Gulf, and Iwo Jima, as well as significant battles in the Pacific Theater. After leaving the Navy, he joined the Army Air Forces. He took part in the Berlin Airdrop in June 1948-May 1949, delivering food and supplies to allied controlled areas of Berlin. During the Korean War, he served on cargo planes, flying food to people on the Korean coast. He left the Air Force with the rank of Staff Sergeant in 1952.

Returning home to New Mexico from the war, Platero worked for the Public Health Service and the Navajo Tribe community health department. He retired in 1990. Platero remains active, going for walks and fishing with his family. There are some things about his time in the military, especially during World War II, he prefers not to remember, according to his daughter, Minga. Mr. Platero talks to his grandchildren weekly, and his pride in their military service is palpable. Mr. Platero is a member of the To'hajiilee Chapter of the Navajo Nation, VFW post 6216, and The American Legion. Platero is surprised to have been here for so long and is proud of his military service.

## 80th Anniversary of the raising of the American Flag at Iwo Jima

On February 23, 1945, four days after the initial assault on the island of Iwo Jima, U.S. Marines took control of the high ground and planted an American flag atop Mt. Suribachi. The flag raising was a powerful symbol of victory, but it did not signal the end of the fight on Iwo Jima. It did however mark a turning point in the battle, motivating the Marines and corpsmen, flushing out an entrenched enemy force and inspiring hope in the hearts of many.



New Mexico veteran Thomas Begay was born in a traditional hogan in a remote area near Two Wells, New Mexico. Although his exact date of birth was not recorded, he celebrated his 100th birthday in November 2024. Begay joined the Marine Corps and attended Code Talker training assigned to the Signal Company for the 5th Marine Division. He was on the front lines at Iwo Jima after being sent to the 27th Marines as a replacement for another Code Talker killed in action.

Navajo Code Talker Thomas H. Begay from Two Wells, New Mexico, recalled what it was like to see the Stars and Stripes fly high over the island. "It was the greatest feeling I ever had," Begay said.

The island, 10 square miles in area, was a Japanese stronghold halfway between Saipan and Tokyo. The Iwo Jima assault started on February 19, 1945, with three Marine divisions and over 80,000 men. U.S. Marines took control of Mount Suribachi four days later and raised the American flag. Joe Rosenthal's iconic photo captured the flag raising and is the model for the Marine Corps War Memorial and the National Museum of the Marine Corps.

The battle, a testament to the ultimate sacrifice, lasted 36 days and claimed the lives of 5,931 U.S. Marines. 209 U.S. Navy corpsmen and surgeons assigned to the U.S. Marines also died, as well as Sailors, Soldiers, and Airmen from other units. More than 110,000 Marines, Sailors, Soldiers, and Airmen served, with more than 26,000 killed or wounded.



Begay was discharged from the Marines in 1946 but joined the Army a year later as a communications specialist and a paratrooper. With the Army, he worked with the 7th Infantry Division in Korea, including at the Chosin Reservoir in late 1950. After his service in Korea he left the military in 1953.

After leaving the military, Thomas Begay worked for the Bureau of Indian Affairs (BIA) on the Navajo reservation as an employment assistance officer, helping Navajos find employment and education opportunities. He has been active in the Navajo Code Talkers Association, public speaking and performing his songs in Navajo about his time in WWII.

The New Mexico Department of Veterans' Services recognizes the rich history of our veteran community and honors the legacy of their sacrifices for our state and country.



# Upcoming DVS Veterans' Property Tax Exemption Events

Both proposed Veterans' Property Tax Exemption Amendments 1 and 2 were passed during the November 2024 General Election and are now undergoing the legislative approval process for enactment.

NMDVS and the TAX REV department will collaborate closely with the County Assessor's offices to develop and implement rules for the upcoming 2025 tax exemption changes.

A revised NMDVS DVS-1 application will be introduced with a new disabled percentage rating certificate for implementation. As soon as the rules process is approved for implementation, information on when to apply for the new certificate will be announced.

## What will change for the 2025 Property Tax Exemption?

**Amendment 1** changes the New Mexico Constitution to extend the existing property tax exemption for 100% disabled veterans and their widows and widowers. This extension now includes veterans with less than 100% disability and their widows or widowers. The exemption amount is based on a veteran's federal service-connected disability rating, as determined by federal law.

**Amendment 2** changes the New Mexico Constitution to increase the Veterans' property tax exemption for honorably discharged members of the armed forces and their widows or widowers from **\$4,000 to \$10,000**. The amount will then be adjusted for inflation after 2025.

DVS will keep you updated on the process and has scheduled veteran property tax exemption events throughout the state to explain the changes for the 2025 tax year. DVS will also have Veteran Service Officers (VSOs) on-site to assist veterans and their eligible dependents with filing VA claims and obtaining federal and state benefits.

Our VSOs also help connect veterans to vital community resources, such as transitional housing and medical and behavioral health care. Information and assistance on federal and state benefits, local veterans' programs, and referral services are available at any of our field office locations.

## The New Mexico Veteran’s Business Outreach Center (VBOC)

The VBOC is funded by a U.S. Small Business Administration (SBA) grant managed by DVS to help veterans, transitioning active service members, National Guard & Reserve members, and their spouses who are interested in starting or growing a small business. It can help with everything from business planning, start-up and expansion funding, marketing, landing federal contracts, and anything else a small business needs to launch and grow.

DVS was the first state agency in the nation funded by the SBA to offer this “one-stop-shop” when the SBA launched this grant program in 2010.

The VBOC is located in the DVS Albuquerque office at 4801 Indian School Road NE/Building 2. Drop-in visits for business counseling are welcome—but scheduling an appointment is strongly recommended.

Staff can also help with applying for state veterans' benefits such as fishing and hunting licenses, veterans' license plates, new property tax exemptions and many more state veterans' benefits.

Please bring a copy of your DD Form 214 Certificate of Release or Discharge from Active Duty, which are necessary for filing all veterans' benefits claims. DVS can help assist veterans file for lost or misplaced DD 214s.

## Department of Veterans Services Employee Spotlight



The New Mexico Department of Veterans' Services (NMDVS) is pleased to welcome Chris Brownlee as our new Procurement and Contracts Specialist. Chris joins us from the Department of Public Safety, where he worked in purchasing. Originally from Jordan, Chris grew up throughout the Middle East and in various states across the U.S. He comes from a long line of military service, with family members who have served in every conflict since the French and Indian Wars.

Chris' grandfather, a World War II Marine, famously advised his father on his deathbed, saying, "Son, I don't care what you do, I'll be proud; just don't be a Marine." Following this advice, his father joined the Army. Chris himself was commissioned as an Army Engineer Officer, serving with the Second Engineer (Combat) Battalion at White Sands Missile Range and deploying with the 573rd Clearance Company. After leaving the Army in 2015, Chris found fulfillment in service, working for various New Mexico agencies and even teaching history.

### Veterans Legacy Memorial Expanded

Find your Veteran  
and add a tribute



The U.S. The Department of Veterans Affairs (VA) expanded the Veterans Legacy Memorial (VLM)- the nation's first digital platform dedicated to the memory of Veterans and service members. Now veterans can tell their own story before they pass away. The new "Your Story, Your Legacy" feature will allow Veterans who have been approved for VA's pre-need eligibility determination for burial in a VA national cemetery to log in to a secure website where they can privately submit images, autobiographies, military and life milestones, and historical documents.

VLM offers family, friends, and now Veterans a way to chronicle the life of a Veteran by uploading written tributes, photos, biographies, documents, and other information. It is the nation's largest online memorial space dedicated to Veterans, with nearly 10 million interactive VLM pages already on the website for those interred in VA national cemeteries, Department of Defense-managed cemeteries, VA grant-funded state/tribal cemeteries, National Park Service cemeteries, and private cemeteries around the world.

VA will keep the content secure until the Veteran passes away and VA approves a request for a burial or memorial benefit. Following approval, submitted content will become public and appear on their VLM page on the public-facing website.

Veterans approved for pre-need eligibility will receive an email directing them to the "Your Story, Your Legacy" landing page. Here is where to apply [online](#).
