In July, VFW Department of New Mexico hired a new Veterans Service officer, Senior Master Sergeant Brian A. Sartori, USAF, Retired. He served for 26 years.

Brian entered the United States Air Force in November 1992. His background includes various duties as Security Forces, Facilities Manager, Education and Training, and First Sergeant.

During his 26 years, he had eleven assignments and numerous deployments supporting Operations Desert Storm, Southern Watch, Enduring Freedom and Iraqi Freedom. He earned the Armed Forces Expeditionary Medal with one oak leaf cluster, Southwest Asia Service Medal with one bronze star, Iraqi Campaign Medal with one bronze star, Global War on Terrorism Service Medal, Korean Defense Service Medal with one oak leaf cluster, and the Air Force Expeditionary Service Ribbon with gold border.

Coming into this position with no experience but a desire to help his fellow veterans and a willingness to learn made his first month very rewarding. He witnessed veterans struggle to understand the disability system and at times saw hopelessness and despair in their faces. Struggling with ailments and fighting to have them recognized can be overwhelming and a daunting task. He accepted this challenge, and with his teammate, Kaitlin (Katie) Jaramillo, they made it their mission to ease the claim process and ensure they can effectively help all veterans and their spouses who seek representation.

He spent this first month working side by side with Katie and was amazed at the knowledge she has and her ability to navigate the channels of the Veterans Administration. He came to realize that this job is a passion to help our Brothers and Sisters in arms. When he sees the look of despair and hopelessness turn to a look of hope, appreciation and a smile, he accepts this small victory, and charges on to help the next veteran.

The reward at the end of the day is a warmth deep knowing inside that you did your best to make someone's day better.

Please welcome Brian to the VFW Department of New Mexico team. When you see him around the Department, welcome him and ask him how things are going. We are hoping this is a great start to another long and prosperous Service Officer for us.

"September is Suicide Prevention Awareness Month.

Veterans are at a much higher risk for developing mental health conditions that often go untreated and lead to a tragic result. For some Veterans, crises can be heightened by their experiences during military service. There are countless factors that contribute to suicidal thoughts and acts for veterans.

Issues like combat exposure, injury, struggling to return to civilian life, military sexual trauma, relationship problems, workplace issues, substance abuse, legal problems and financial struggles. Any of these factors can add to the risk of self-harm and committing suicide. Now more than ever it's important to give emotional support to veterans. Some of the most significant protective factor in suicide prevention is connection and inclusion.

We all have an opportunity to relate to our fellow comrades and look out for one another. Take the time to relate and connect with fellow members of the VFW as well as other Veterans. We can all work together, build interpersonal relationships and

connect. It is through these relationships that we create the opportunity to help one another through hardships and stress. Posts should be conscious of members experiencing such challenges and talk with them more readily. I urge you to help each other, engage your members and involve the multitude of services that can help you. Suicide can be prevented with enough awareness and the right resources for those struggling.

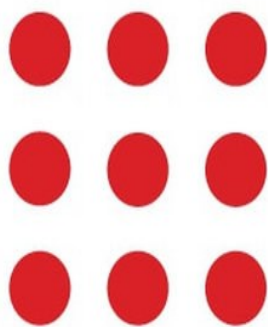

9/11 Remembered

The Day most Americans over the age of 25 will
never forget:

S E P T E M B E R 11, 2001

On the calendar, it is "Patriot Day," or "National Day
of Service and Remembrance." To me, it's the day I
woke up to get ready for work, turned on the TV and
was shocked by the news and what I saw on the
television, as the Twin Towers crumbled and fell. As
the story unfolded, the Pentagon got hit. The
second plane went down in Pennsylvania, where
lives were taken from this Earth too early, and
where lives were saved and new heroes emerged. I
did finally make it into work, to join the office
complex as it was glued to the TV and radios in
disbelief.

I visited New York about a year after September 11,
and could still hear the cries and the people trapped
in the buildings - such an eerie feeling, and the
mourning of loved ones left behind was one of the
most somber feelings I ever felt. Talking to the kids
and families of Ground Zero victims, and talking to
other governmental officials at Ground Zero was
humbling to hear what they went through. How I got
to talk to the families of Ground Zero was purely
accidental.

I'm writing this article to announce that on Saturday
September 11, 2021, Gadsden Memorial Post #
4384 and its Auxiliary is having a FLAG
RETIREMENT CEREMONY at the Post, starting at
10:00 am. The community is invited and lunch will
be provided after the ceremony. This ceremony
reminds me of all the tattered, torn, scorched and
half burnt flags I saw walking through some of the
back streets at Ground Zero that had not been
cleaned up yet. To me, it's a respectful, beautiful
way to honor and remember those veteran men and
women who gave their all to this country for our
freedom, but also to remember those who left this
earth believing in freedom.

On Aug. 20, 2020 at the VFW National Council of Administration meeting, Lenwood Hampton was elected to a four-year term on the VFW's National Council of Administration, representing the Department of New Mexico.

Project Blue Light

What is Project Blue Light?

If someone you love is a law enforcement officer, you probably think often about ways to encourage them and honor their sacrifices. One of the most popular nationwide public movements designed to support the police force and remember fallen officers is Project Blue Light: a memorial that illuminates the night sky every holiday season.

What is Project Blue Light? We want to share the history and symbolism behind this gesture of goodwill, and some tips for how to observe and participate.

The History of Project Blue Light.

Project Blue Light began in 1989 when a woman named Dolly Craig wrote to Philadelphia's C. O. P. S. chapter to let them know she would be placing a blue light in her window during the holiday season to honor her late son-in-law, Philadelphia Police Officer Danny Gleason.

The idea has since been shared with C. O. P. S. chapters nationwide and grows bigger each year as survivors band together and remember the loved ones they've lost in the line of duty. Blue lights now burn bright in nearly 32,000 windows over the holidays.

How to Participate in Project Blue Light.

If you or someone you know has lost a loved one who is a law enforcement officer, participating in Project Blue Light can be a source of comfort or a meaningful way to show your support.

It can communicate that although your loved one is no longer celebrating the holidays with you, they are still present in your home and in your heart. It also demonstrates to other police officers that you honor their fallen brethren and appreciate the gravity of their sacrifices. The holidays are a poignant and sometimes painful time for officers and survivors who are missing partners, or loved ones who have passed away.

You can find blue LED tea lights on Amazon. You can find blue Christmas lights online. You can set them in your window when you set up the rest of your festive holiday décor. Optionally, you can also display a thin blue line flag to show further solidarity to your local police force.

As the holiday season ends and we head toward a new year, we hope you will consider remembering the police officers who made the ultimate sacrifice to keep our communities safe.



Post 11999

New Mexico's Veterans of Foreign Wars (VFW) Department Commander, Roy Maldonado, traveled to Cloudcroft on August 14 to honor Cloudcroft's VFW Post 11999, which was recently recognized as the #1 Post in New Mexico and the #1 Post in VFW Division 9. (For reference, there are only 11 divisions in the entire VFW worldwide.) Additionally, Post 11999 was also bestowed with the coveted All-American Award, which honors top Posts globally, and recognizes Posts achieving the most for veterans, their families and the communities they serve.

Commander Maldonado heads all VFW Posts in the State of New Mexico, so it was truly an honor that he came all the way to Cloudcroft to congratulate the Village's VFW Post members personally. In his remarks, he mentioned how impressed he is with the consistent accomplishments of VFW Post 11999, adding that "whenever another VFW Post asks for guidance on how to get things done, I suggest they visit Cloudcroft, because the Cloudcroft VFW makes things happen." Richard Hoschar, VFW District 3 Commander, who was also in attendance, echoed those sentiments by stating "I am always amazed by the volume of veteran and community service this Post accomplishes. Their awards are well-deserved."

The awards are based on a variety of criteria, including new membership enrollments, community involvement and service to local veterans. VFW Post Commander Richard Herold said, "I'm proud and honored to work with veterans and their families who continue to serve our country and our wonderful mountain community in a variety of ways. I feel truly blessed to be a part of a 100% voluntary organization that provides so much." Recipients of these awards are considered the best of the best, and Post 11999 is proud to offer its best to the Cloudcroft community.

After an exceptionally busy spring and summer, Post 11999 shows no signs of slowing down. They kicked off August by supporting the Otero County Electric Cooperative's 82nd Annual Meeting, opening the event with a military color guard ceremony. This was the first of such meetings held in two years, as last year's meeting was cancelled due to public health restrictions during the COVID pandemic.

On three separate September weekends, the Post will display American flags in front of participating Cloudcroft businesses over Labor Day (Sept 6), Patriot's Day (Sept 11), and POW/MIA Day (Sept 18). We currently have 67 participants in this program helping to celebrate these holidays in patriotic style.

Additionally on September 11, the Post will host the 5th Annual George G. Hevner Memorial Charity Golf Tournament at the Cloudcroft Lodge Golf Course. Not only is this a highly anticipated, fun and friendly competition, but the fact that it is held on Patriot's Day - the 20th anniversary of the deadliest attacks on American soil by a foreign entity - adds additional patriotic significance to the event. Those strategically planned terrorist attacks against the United States ushered in an era of wartime commitments which have kept many of our veterans overseas for extended tours of duty and away from their loved ones at home. The Golf tournament will be structured as a 4-person scramble with a plethora of prizes, including the possibility of winning a new car from Desert Sun Motors for a hole-in-one. 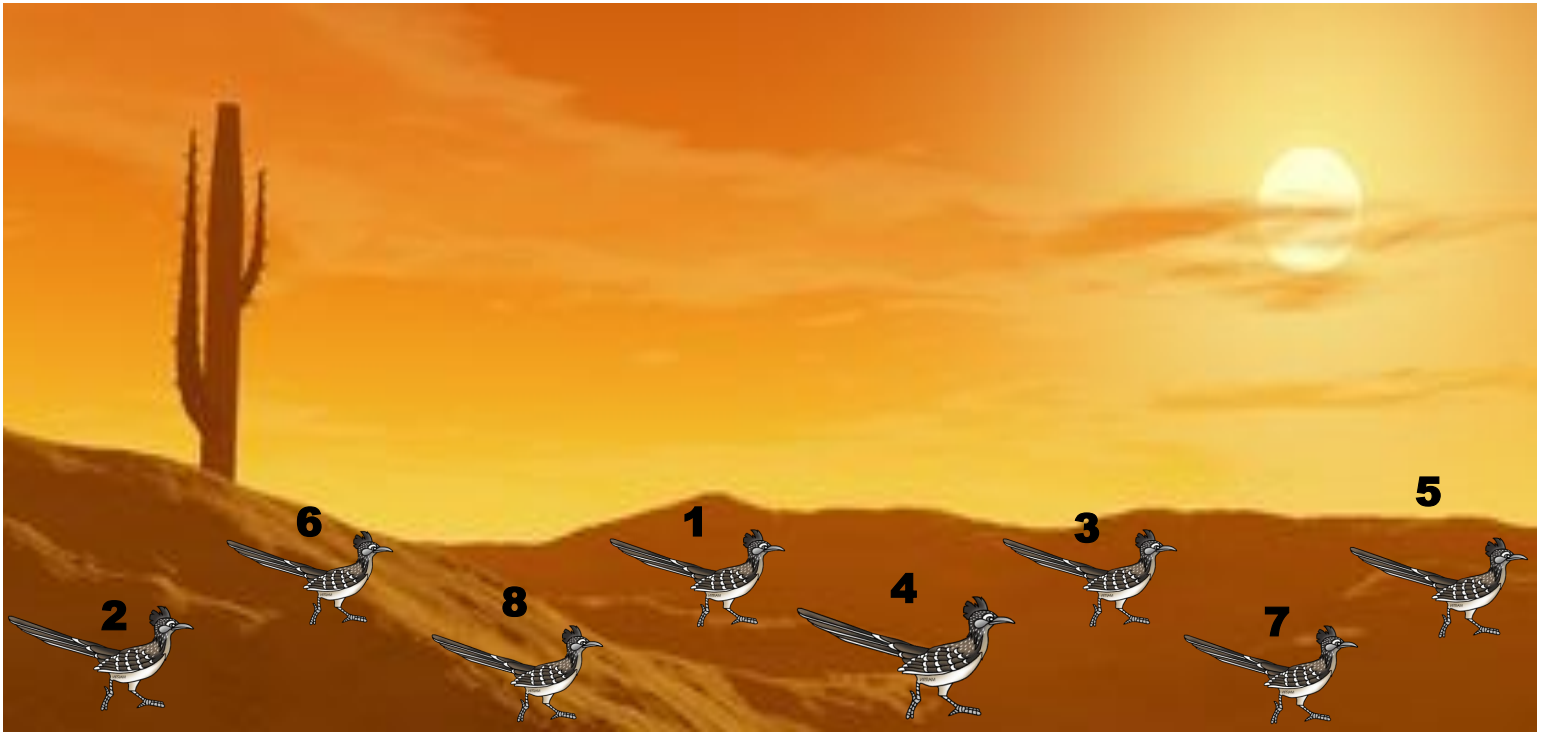
