KC MacDonald, a teacher in Clark Fork, Idaho, made arrangements with a school in Houston, Texas that had been flooded during the hurricanes this year. The school in Idaho was going to raise school supplies and ship them to the school in Texas. He just needed a way to get the supplies from Idaho to Texas. So, he talked to Rockey about the situation. Rockey then sent out a request to the other Senior Vice Commanders to help him out. The idea was raised to load the supplies into a U-Haul trailer and tow it all the way to Texas. So the call went out.

The trailer started out in Clark Falls, Idaho on Sunday, November 12. It then made the trip through Idaho and Utah to the Four Corners Monument where Mark Decker received it on Wednesday, November 15 at 1430. Mark then drove the trailer to meet Jarod Maples in Belen that night. Jarod took the trailer to Las Cruces and met up with Judy Hays and Rudy Saucedo. Rudy and Judy took the trailer to El Paso and passed it along to the Department of Texas.

The VFW and VFWA members that made this trip, were the reason this was possible. With very little time to coordinate all of the places and times, changing up personal time, and working around Post meetings, this came to

happen with no problems at all.

The trailer was delivered to Texas on time and with no problems on Thursday, November 16. The Department of Texas then transported the truck across Texas to Houston. It arrived in Houston on Saturday, November 18. It was stored there until Monday, November 27, where it was presented to the school with KC MacDonald there to present the supplies to the principal.

This is just another example of how the VFW and VFWA step up and help those in need. A great deal of thanks goes out to all of the people that helped move the trailer across New Mexico. These members did a great job and worked wonderfully together.

As of November 20, we are ninth in the world for membership at 87.87%. We need 1,152 more members to be at 100%. We have 1,454 unpaid members right now. So if we can get these unpaid members to renew, we will be over 100% for the year.

All Posts have been getting

unpaid roster from Department this year. Please sit down and call the ones that have a phone number, send an email to those that have an email address, or send a little note to the rest in your Post. This shows the members that you actually care about them. Ask them how they are doing and if they need help in some way. If they need assistance with money to renew, you can use your relief dues to help out in this area. If they say they do not want to renew, ask them why. We need to know these answers to this. By learning these reasons, we can do better at the Post, Department, and National level.

If you have a college in your town, go talk to the Student Veterans Association. These are veterans that are going to school and have joined an organization already. Most of them are eligible for the VFW. Ask them how you can help them. What do they

need? Try to fulfill these needs if possible. That goes on your Community Service sheet, which you can turn in to me as a SVA activity, and you might get new members out of it also.

## Judge Advocate's Message

In my position as your Judge Advocate, I have been asked to review a number of actions taken by Posts and/or Commanders for compliance with VFW By-Laws and the Manual of Procedure. In many instances, my review determined that many of the violations could have been prevented if the Post and its Officers had taken the time to refer to the current Podium Edition of the By-Laws. In the last five or six years there have been

more than 500 changes approved by the National Conventions. If your Post Officers are using Podium Editions that are four or five years old, how can you possibly expect to have your Post Commander's actions upheld upon appeal? Not only the Commander, but the Quartermaster, the line officers, and the Judge Advocate should get a copy of the new Podium Edition every year.

Each officer should become familiar with all of Article II-Posts in both the By-Laws and Manual of Procedure, and especially Section 218 Officers and

Chairmen, Duties and Obligations. How can the Judge Advocate fulfill his duties as the legal advisor if he doesn't have the current By-Laws, the Department By-Laws, and the Post By-Laws?

Commanders, the Podium Edition should be your "Bible" and should always be readily available for you to refer to at any time. The By-Laws are not "Top Secret." Share them with any members who want to learn more about the workings of the VFW. Remember, the Post belongs to its members, and it's the obligation of each and every member to protect the Post's Charter.

The old days of Posts "doing whatever they want, whenever they want" are long gone. If you don't follow the rules, you won't have a Post for long. Don't jeopardize your Charter...follow the rules! But, you have to know what the rules are so you can follow them. Get the 2018 Podium Edition if your Post doesn't have it already. If you have it, learn it!

I am available to anyone feeling that they need assistance in interpreting the By-Laws. I can be reached at 575-318-3149. If I don't have the answer to your question, I will find the answer for you. Sometimes asking a question can save a whole bunch of problems later.

Thomas Tradewell was elected Commander-in-Chief of the Veterans of Foreign Wars on August 20, 2009 at the VFW 110th national convention, held in Phoenix, Arizona.

Tradewell served in the U. S. Army from 1966-1968 and earned VFW eligibility while serving with B Company 26th Engineers 198<sup>th</sup> Light Infantry Brigade (Americal Division) in South Vietnam as a demolition specialist. His decorations include the Vietnam Service Medal, Vietnam Campaign Medal, Purple Heart Medal, and Good Conduct Medal.

Tradewell joined the VFW in 1968 at Post 6498 in Milwaukee, where he is a Life Member. He has served in elected and appointed positions at the Post, District, and Department (State) levels, culminating with his election as Department Commander from 1999-2000. He served as National Inspector General from 2001-2002. He also served as the District 11 National Council representative for members from the Departments of Wisconsin and Iowa in 2003-2005.

Tradewell earned an Associate’s degree in industrial safety and retired from Briggs and Stratton in 1998 as a Metallurgy Laboratory Technician after 30 years of service.

He is a member of the Military Order of the Purple Heart, Military Order of the Cootie, American Legion, Disabled American Veterans, Vietnam Veterans of America, and Combat Veterans Motorcycle Association.

Tradewell married Sharon in 1966 and they make their home in Sussex, Wis.

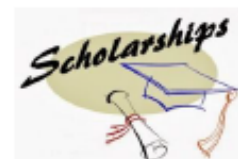

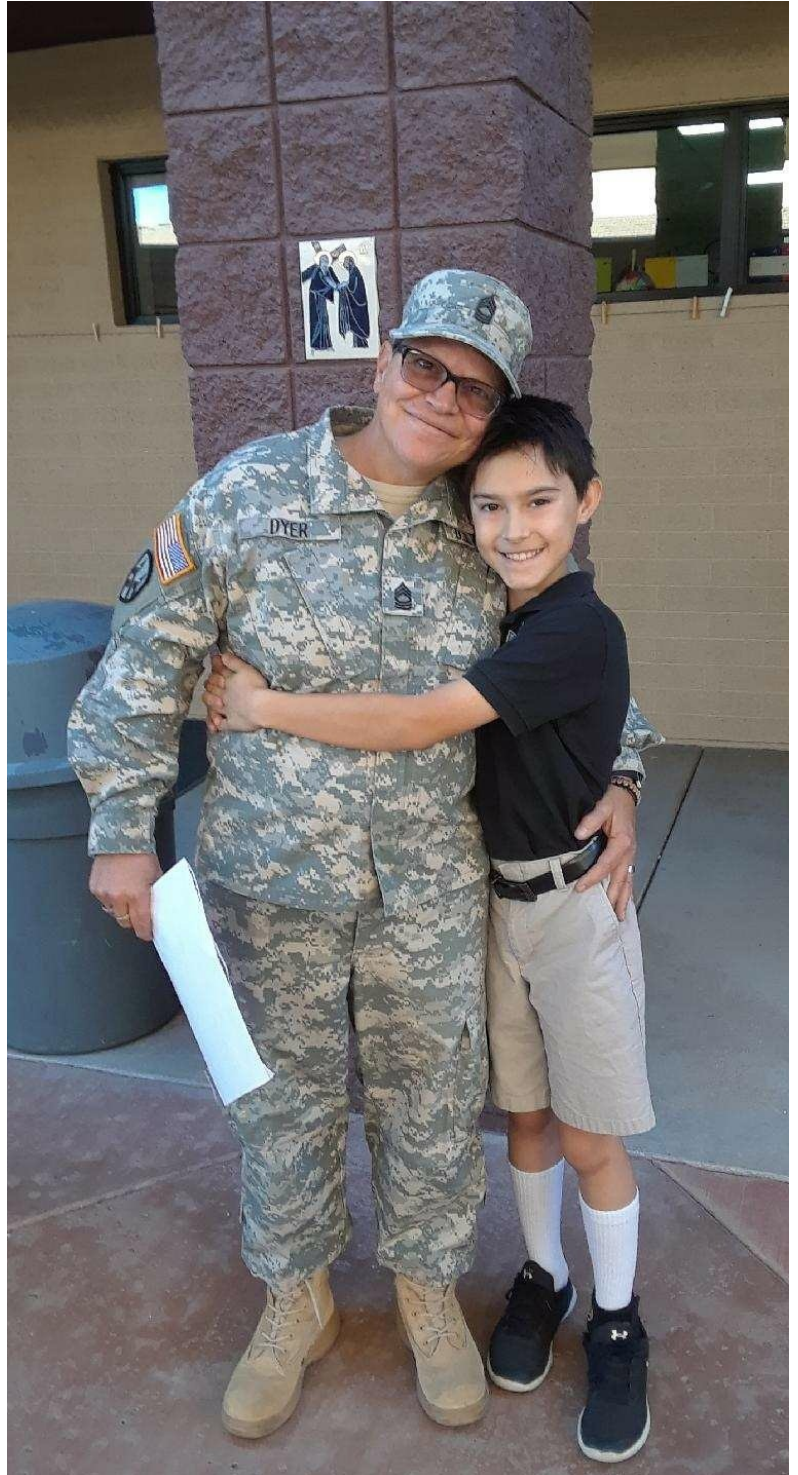

## 100 Cities Memorial Grants

### Apply Today for a 100 Cities/100 Memorials Matching Grant

*Round two applications being taken until January 15, 2018*

**WASHINGTON (Oct. 23, 2017)** – In observance of the centennial of World War I, a total of 100 matching grants of up to \$2,000 apiece are being awarded for the restoration, conservation, or even creation of 100 World War I Memorials across the United States.

The first 50 “WWI Centennial Memorials” were announced on Sept. 27, 2017 and grant applications for the second 50 awards are being taken now. Applications can be submitted until January 15, 2018. The program management expects to announce the second group of 50 awardees on April 6, 2018.

Any organization, group, municipal government, or individual may apply. The memorial or monument must be WWI related, must be in the 50 United States or U.S. territories, and the project must be, or have been completed between January 1, 2014 and November 18, 2018.

To date, both American Legion and Veterans of Foreign Wars Posts from around the country have participated, as well as many other veterans’ service organizations, community groups, city, state and municipal organizations, local historic preservations societies, and even individuals.

WWI memorial restoration, preservation, and creation projects are being undertaken around the country during this centennial period. Some of the projects may not know about the program, which not only provides some financial assistance in the form of a matching grant, but most importantly, applicants get to tie into a national program, and awardees receive an official federal designation as a “WWI Centennial Memorial.”

Interested parties should go to [ww1cc.org/100memorials](http://ww1cc.org/100memorials) where they can learn about the details of the program, read or download the competition manual, submit a grant application, and sign up for an informational blog about the program that will keep them updated over the coming months.

By restoring these monuments and memorials, many of which bear the names of those members of the community who served and fell in the “war that changed the world,” the sponsors of the 100 Cities/100 Memorials initiative hope not only to honor those who served, but to raise awareness of this momentous event in our nation’s history, and increase each community’s understanding of their town’s and city’s place in military history.

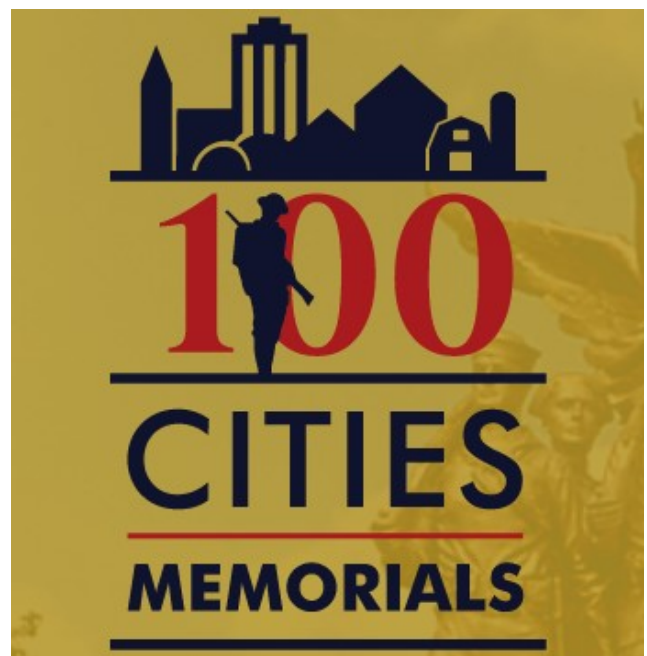
It is our great hope that the 100 Cities/100 Memorials initiative will help unite the nation in a conversation and collective celebration of our victory in World War I. We hope to properly recognize the contributions of those who served and those who made the ultimate sacrifice in defense of liberty and freedom.

The 100 Cities/100 Memorials program was created and is sponsored by the U.S. World War One Centennial Commission and the Pritzker Military Museum and Library. Both the American Legion and the Veterans of Foreign Wars are signed on as supporting organizations.

## Stand Downs

Stand Downs are typically one- to three-day events providing supplies and services to homeless veterans, such as food, shelter, clothing, health screenings, and VA Social Security benefits counseling. Veterans can also receive referrals to other forms of assistance such as health care, housing solutions,

employment, substance counseling, and mental health counseling. They are collaborative events, coordinated between local VA Medical Centers, other government agencies, and community-based homeless service providers.

The original Stand Down for homeless veterans was modeled after the Stand Down concept used during the Vietnam War to provide a safe retreat for units returning from combat operations. At secure base camp areas, troops were able to take care of

personal hygiene, get clean uniforms, enjoy warm meals, receive medical and dental care, mail and receive letters, and enjoy the camaraderie of friends in a safe environment. Stand Down afforded battle-weary soldiers the opportunity to renew their spirit, health, and overall sense of well-being.

That is the purpose of the Stand Down for homeless veterans, and achieving those objectives requires a wide range of support services and time. The program is successful because it brings these services to one location, making them more accessible to homeless veterans.

The VFW supports homeless veterans in many ways including donations to homeless shelters, support of regional “stand downs,” donating clothing and personal hygiene items, and fighting for more government resources to reduce the homeless population and put veterans back to work. Posts and individuals can send donations to the Department’s Homeless Veterans fund in any amount which will be utilized to provide services to our homeless comrades. There is a variety of reasons why veterans are homeless, and the Department of New Mexico is committed to providing help to put an end to this problem.

## New Veterans Cemetery in Gallup

On Wednesday October 25, the New Mexico Department of Veteran Services held a groundbreaking for the newest State Veterans Cemetery, which was held at the future site. The master of ceremonies, Jack Fox, Cabinet Secretary for the New Mexico Department of Veteran Services, started the program at two o'clock with a welcome to approximately 200 crowd members and special guests.

Gallup Mayor Jackie McKinney talked about how this cemetery would help local veterans be interned close to home and family. He thanked the New Mexico DVS and VA Cemetery Grants Program Director George Eisenbach, Governor Martinez, and others for working so hard for this and how pleased he was that it was finally happening.

Korea War veteran and Medal of Honor winner Hiroshi Miyamura talked next. He was very touched for being invited to the ceremony and pleased with the opening of a cemetery in Gallup. He looks forward to having a fourth veterans' cemetery in the state of New Mexico.

George Eisenbach followed, who talked about how Gallup and the entire state of New Mexico will benefit from the cemetery. He knows how much effort, time, and sweat was put into the project.

Governor Martinez then spoke about how her Mother-in-Law had a hard choice when her husband died. She could have either buried him in Santa Fe not allowing frequent visits, or she could have buried him in the local cemetery in Las Cruces. She decided to go to Las Cruces so that she could tend to his grave every week. Governor Martinez does not want families in New Mexico to have to decide that fate ever again. This was the driving reason she started the project in 2013. She wants to have four State Veterans Cemeteries very soon, with this one being the second.

The purpose of the State Veterans Cemetery program is to provide an honorable final resting place closer to home. This cemetery, when fully open, will be able to have 20,000 veterans and their families interned. They have opened one cemetery in Fort Stanton in 2014. The one in Gallup will be open Memorial Day 2019, with Angel Fire and Carlsbad to get on in the future.

This initiative is to help our two National Cemeteries, Santa Fe and Fort Bayard, to lay to rest the more than 150,000 veterans who live beyond the VA designated 75-mile radius to the cemetery. In 2015 the VA approved the state's application and awarded a grant for \$5.7 million for Fort Stanton. In 2017 the VA Cemetery Grants Program awarded New Mexico a grant of \$6.7 million for the Gallup cemetery. The grants for the other two cemeteries are still in the process of being accepted.

The VA cemetery rules for internment will apply for the Gallup cemetery also. Applications will be accepted after the cemetery is opened. You may get more information on this program and the cemetery at [www.dvs.state.nm.us](http://www.dvs.state.nm.us).

## VFW/VFWA 9517 Veteran's Day Week

VFW 9517 started our week of Veterans Day out on Friday, November 3 at the Farmington Public Library. Mark Decker, Post QM, and Betty Decker, VFWA Sr Vice President, had flag education class at the library. They told patrons of the library about the proper way to fold the flag, handle the flag, and when it should be displayed. They handed out small hand-held flags, coloring books about the Pledge of Allegiance from the VFW store, and Flag Education pamphlets from the VFW Auxiliary website. They also demonstrated the proper way to fold the flag and had some people actually fold the flag. All told they talked to about 20 people at this class.

On Wednesday, November 8 Mark Decker went to Central Elementary School in Bloomfield to teach 1<sup>st</sup> graders about flag etiquette. There were about 100 students for this class in which he talked about some of the history of the flag, the different names of the flag, how it should be displayed, when it should be displayed, and how you should show respect to the flag. After his speech, he demonstrated how to fold the flag and had two students fold the flag for themselves. He then had a question and answer period with the students and teachers about the flag. The students were very excited to learn the history and wanted to tell some of their knowledge of the flag. The students then got a small flag, coloring booklet about the Pledge of Allegiance, and a handout called "Flag Education for Children." The students even asked Mark to come

back again.

On Friday, November 10 Mark Decker went to Central Elementary School in Bloomfield for their Veterans Day ceremony. The Bloomfield Junior High School ROTC presented the colors and did Honor Guard for the Pledge of Allegiance and playing of the National Anthem. Mrs. Chestnut, the organizer of the event, introduced Mark Decker. After that she had the students that had veterans in their families there introduce the veterans and present them with a hand colored flag with their name and dates of service on it. There were 41 veterans introduced. Then they played "God Bless the USA". All the students came up and thanked the veterans for their service and asked questions about when they were in the military.

On Saturday, November 11 and Sunday, November 12, the VFW and VFWA 9517 handed out Buddy Poppies at the 7-2-11 and City Market in Shiprock. They handed out about 1,500 Buddy Poppies and talked to many veterans about the VFW. They raised around \$500 over the two days.

During this week VFW and VFWA 9517 also judged their entries for Voice of Democracy, Patriot's Pen, and Teacher Award entries. The winners in all of the categories were sent to District 1 for judging at the District level.

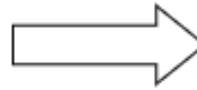

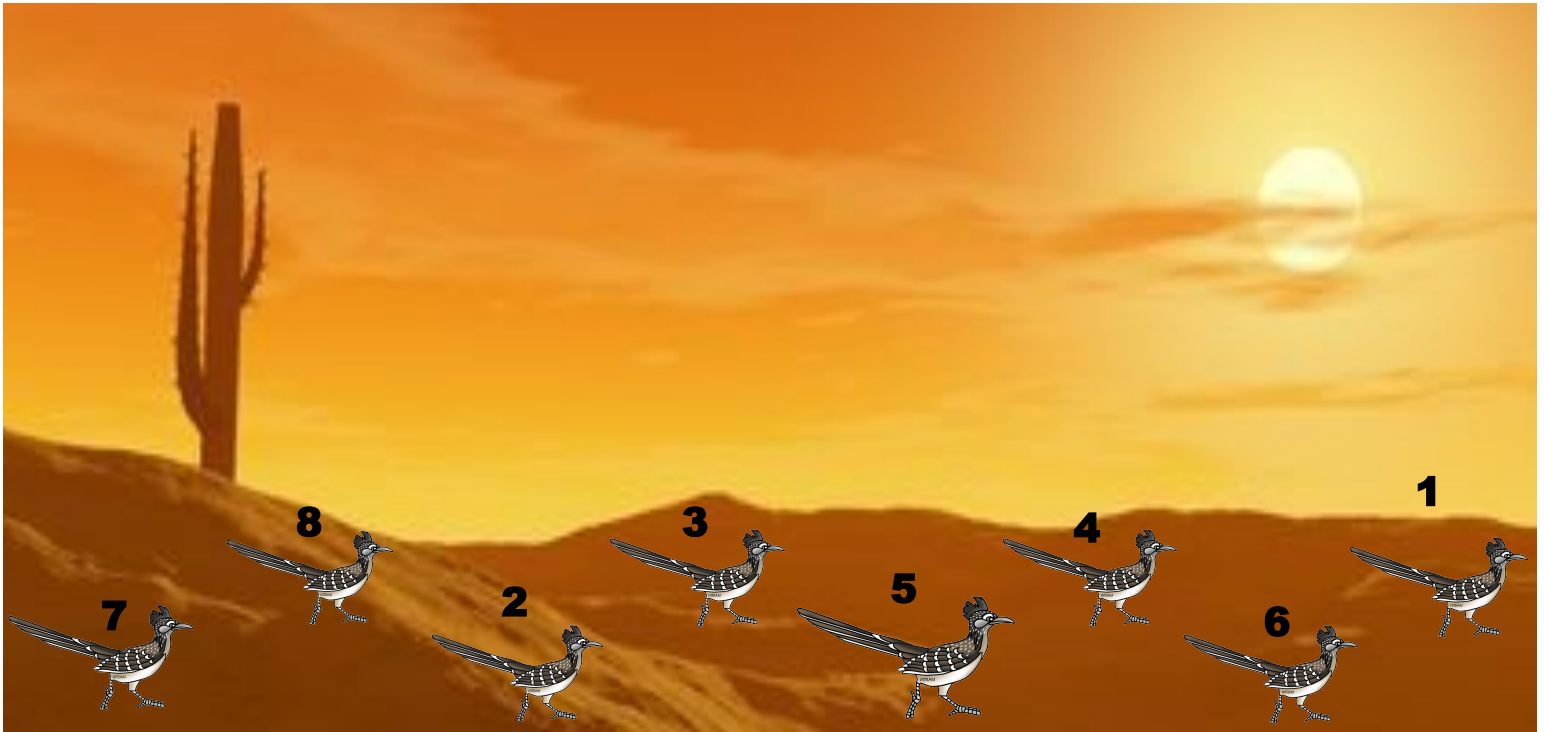

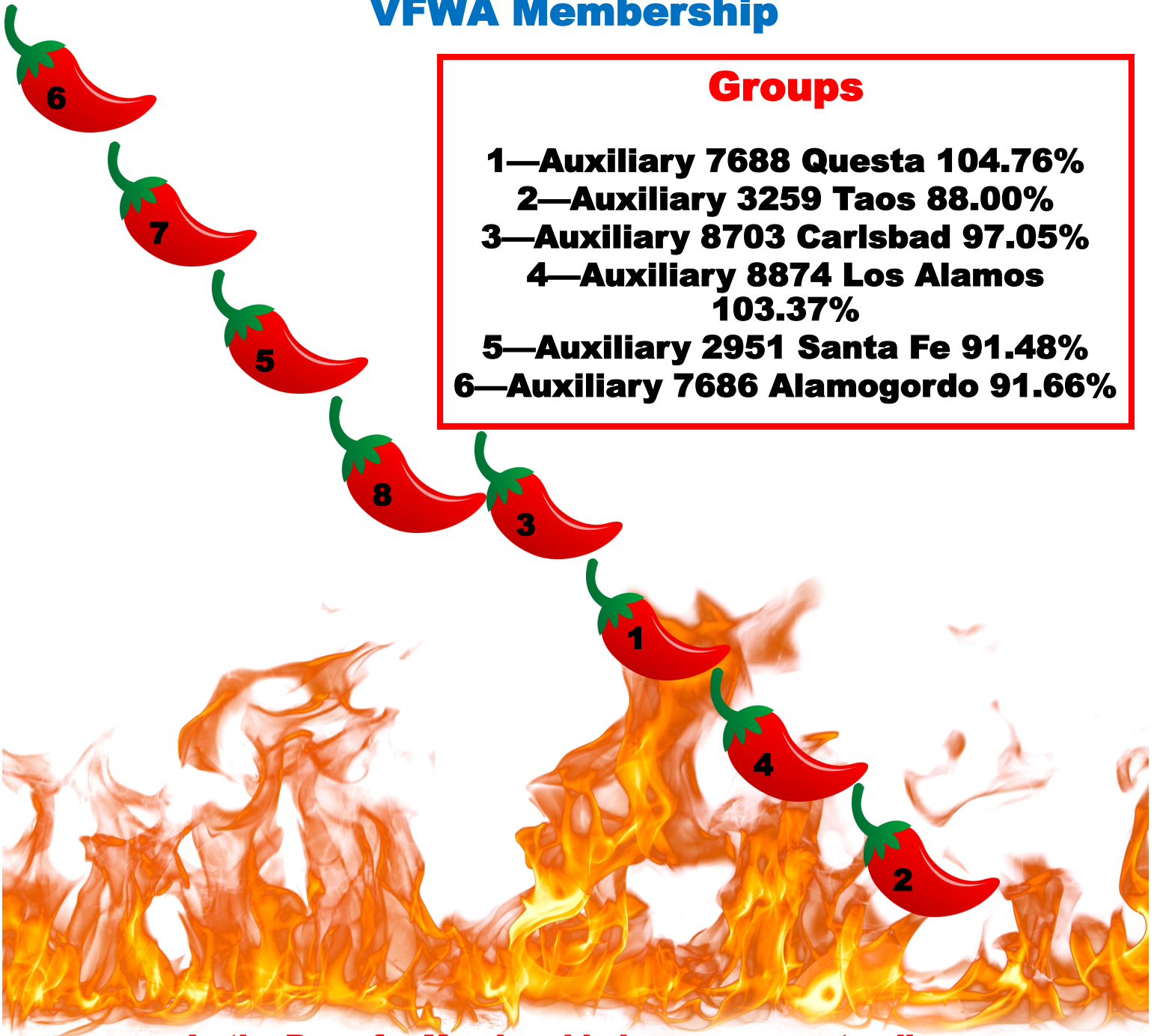
